 4. Delete Table of Contents and Replace with new Table of Contents.
 5. Delete Section 01 00 10 and Replace with new Section 01 00 10 GENERAL REQUIREMENTS.
 6. Delete Section 01 29 00 and replace with new Section 01 29 10 METHODS OF MEASUREMENT AND PAYMENT.
 7. Delete Section 31 24 13.01 PERMANENT GARBAGE CONTAINERS.
 8. Delete Section 32 00 03 and replace with new Section 32 00 03 ASPHALT CONCRETE PAVEMENT.

CLARIFICATIONS

A. On page 3 of 3 in Section 31 11 00 CLEARING & GRUBBING, in Article 3.6.1, replace the first sentence with:

“Remove cleared and grubbed materials to burn pile in wood lot, located within 500m of the Astotin Recreation Area.”

B. On page 3 of 3 in Section 31 11 00 CLEARING & GRUBBING, in Article 3.6 Removal and Disposal, point .2 replace the following as the first sentence:

“Cut timber greater than 125 mm diameter to 450mm lengths and stockpile as indicated.”

C. On page 1 of 4 in Section 32 92 19.13 MECHANICAL SEEDING, in Article 1.2 Measurement and Payment, point .1, replace the following as the first sentence:

“Payment for seeding will be made at the unit price bid per square metre of actual surface measurements taken.”

QUESTIONS and ANSWERS

Q₁ Who completes the utility locates on the project?

A₁ The Contractor is responsible for locating both the franchise and owner’s utilities. Contractor can use anyone but is recommended to use 2nd Call utility locator out of Vegreville, who is familiar with the area and who does the locating for Parks Canada.

- Q₂** What are the haul routes and weight restrictions on the Park Access Roads?
A₂ Haul routes are via Hwy 16 and Hwy 831 and weight restrictions on the Park Access Roads will be the same as those restrictions placed on Highway 831 South of Lamont. This will include the percent axle weights and the beginning and end of the ban restrictions.
- Q₃** What gates may be used by the Contractors to access the work areas?
A₃ Contractors will be provided with keys for “contractor locks” on gates accessing work areas.
- Q₄** How is the line painting being paid for?
A₄ Line painting is part of the lump sum payment.
- Q₅** Does the Contractor have to complete any testing on the project?
A₅ Refer to Section 01 45 00 QUALITY ASSURANCE/CONTROL, Article 1.5.
- Q₆** Where can waste material be disposed of?
A₆ Asphalt materials must be hauled and disposed of off site. Excess topsoil or clean excavated materials, brush and clearing debris for burning can be disposed of in the wood lot area, approximately 500m from the Astotin Day Use Area.
- Q₇** Where should questions be directed during the Tender period?
A₇ Questions arising during the Tender period should be directed to Tammy Hugo as per the Invitation to Tender Documents.
- Q₈** What days and hours are allowed for work on this contract?
A₈ Please refer to Article 16.1 in the General Requirements. Site is to be left in a safe condition prior to shutdown for weekends or holidays.
- Q₉** With Contractor supply of survey, can Amec be used for survey layout?
A₉ Yes, Amec can be used for survey layout.
- Q₁₀** The tender form has a Lump Sum item as well as unit rates. Does this mean that if it's not detailed in the unit rates that everything else is covered and paid as a Lump Sum?
A₁₀ All work not identified in the unit price table is to be included in the contractor's Lump Sum portion of the Combined price form.
- Q₁₁** Will you allow staged road closures?
A₁₁ Access to all areas within the Astotin Recreation area must be maintained throughout the contract. Some sections of the roadway may be temporarily closed, so long as all areas can be accessed via properly signed detour routes.
- Q₁₂** Are temporary signs required to be bilingual?
A₁₂ English only construction signs are acceptable.
- Q₁₃** Who covers the cost of a migratory bird survey for the clearing operations?
A₁₃ If a migratory bird survey is required, it will be performed by Parks Canada staff.
- Q₁₄** Is it possible to get sign drawings so we can figure out what is required?
A₁₄ Typical road construction and detour signage is acceptable for the project.
- Q₁₅** Do water monitoring well casings observed in the road surface require protection or adjustment? Does the owner have a record of or number of well casings?
A₁₅ The owner has no record of these well casings, they do not require protection, they are to be removed and turned over to Departmental representative.

Q₁₆ Has Telus been notified of the construction and the potential impact to their lines?

A₁₆ The contractor shall contact Alberta One-call and have the lines located prior to construction. No impact on the existing lines is envisioned.

Q₁₇ Is dewatering of wetlands acceptable for culvert installations?

A₁₇ No, areas should be dyked off with native material in order to complete the work and then restored to preconstruction condition on completion.

Q₁₈ Has the property owner and/or their consultant had an Aquatic Environmental Assessment of the wetland performed?

A₁₈ Parks Canada has completed an environmental review of the project. The environmental mitigation measures will be distributed by Addendum.
