THIS ADDENDUM IS RAISED TO PROVIDE THE FOLLOWING ANSWERS TO QUESTIONS PROVIDED BY BIDDERS.

THE FOLLOWING CHANGES IN THE TENDER DOCUMENTS ARE EFFECTIVE IMMEDIATELY. THIS ADDENDUM WILL FORM PART OF THE CONTRACT DOCUMENTS.

Question:

As a general comment the Form Table 1.4 on page 3 of 7 labelled "Proposal Price Breakdown Table for the Design and Construction Services" does not seem to match up with the items described in the scope of work.

Here is my attempt to describe the discrepancies:

In the Scope of Work, (As amended by Change #1)	On Form 1.4 Proposed Price Breakdown
Coppermine Trail upper segment from Mile Brook Campsites - the scope of work asks for six climbing turns	there is not a provision for this item
Coppermine Trail upper segment from Mile Brook Campsites - the scope of work does not ask for grade reversals	line item 31 asks for a cost for grade reversals but does not specify the number
Coppermine Trail upper segment - the scope of work asks for some wet crossings but does not specify the number	there is not a provision for this item
Goose River Trail Restoration from	line item 13 asks for a cost for wet crossings

Campsites - the scope of work does not ask for wet crossings (amend #1) -	but does not specify the number

There is not a provision on the Form 1.4 Proposed Price Breakdown for the following - Trail Design Costs - Hydrological Studies - Structural Engineering Costs - Civil Engineering Costs yet all are mentioned to be included in the total evaluated price. As well there is no provision on Form 1.4 for project overheads such as the costs of bid bonding, insurance, office expenses and project management costs. In my opinion to have these items lumped in to the broken down unit prices would skew these unit prices making the not very useful.

Answer:

The Proposed Price Breakdown Table 1.4 is provided 'as is' for information to allow the bidders to formulate a **Total Evaluated Price** as identified in Annex C: Bid Price Form. It is the Total Evaluated Price that will be evaluated. The itemized unit prices in Table 1.4 will not be used as a basis for evaluation. Bidders are to use the described **Scope of Work identified in 1.10** as a basis for Total Evaluated Price.

Trail Design Costs include all required hydrological studies, structural engineering costs, civil engineering costs and disbursements. All Trail design costs are to be included in the **Total Evaluated Price**. Also included in the Total Evaluated price are project overheads such as the costs of bid bonding, insurance, office expenses and project management costs.
