Q60	In Part 4 Evaluation Procedures and Basis of Selection, 4.3.4 Permitted Evaluation Report Responses, (a) Section I – technical Review, it states that “Bidders may submit information only in response to those items specifically identified in the Preliminary Evaluation Report, except where the addition of such information will necessarily result in a change to the information regarding other components (including a change to a component). Any other changes to the bid shall be considered new information and will be disregarded...”. Please explain what is meant by “Any other changes to the bid shall be considered new information and will be disregarded”.	<p>Any additional or different information provided in response to an item noted as a deficiency in a PER must directly address the said item to demonstrate compliance with the solicitation requirement in question where the deficiency was identified.</p> <p>For example, if a bidder’s experience provided for a particular requirement has been noted as an item of deficiency in that it is not its own but that of an affiliate (requirement is for experience of the bidder itself and not its affiliates or parent company), the bidder may only provide additional or different information with respect to the experience it has bid for that particular requirement. It cannot change its corporate structure (i.e., claim to be a Joint Venture) to show compliancy with the requirement - as the deficiency to be corrected is with respect to the experience put forth by the bidder, not the identity of the bidder.</p>
