AMENDMENT 003

The purpose of this amendment is to answer questions from a supplier.

Question 3

Are the suits to be similar for all 3 teams, or are we designing 3 different suits?

Answer 3

The design for the jacket must be the same for all teams but with different names, colors and signature symbols associated with each team. We must show to other participating countries that even though they are three different teams, they belong to the same Canadian delegation. The use of other colors is welcomed but must be the same for all three teams. Pants and shorts must be the same colour for all three teams and must match the jacket and t-shirt. (See section 4 in Statement of work)

Question 4

For the t-shirts, are you looking for something solid color or to incorporate all the team colors?

Answer 4

The design for the T-shirts should be similar for all three teams except for the team's colored signature logo. They need to at least harmonize with the rest of their respective team items. Other team colors can be incorporated in the design if you wish to do so but they are not mandatory. (See section 4 in Statement of work)

All other terms and conditions remain unchanged.
