Amendment 02

This amendment is being raised to distribute answers to bidder questions from site visit on June 2, 2016.

BIDDER QUESTIONS

1. Are kitchen appliances part the contract?

A: Yes, as specified in the specification package.

2. Are there electrical drawings?

A: No, there are not, but majority of the information can be found on the Architectural drawings, particularly the RCP. Similarly the mechanical drawings are only for the kitchen area renovation, the rest of the information for mechanical work can be found on the architectural drawings.

3. Base of veranda is open to air, should this be sealed to make 3 season room?

A: Yes.

Reference A2.0 - Building Elevations and Sections:

“Remove existing screen around base of veranda, provide new 19x140 pressure treated (brown) wood base board around the interior and exterior of the veranda to seal the base of walls.”

4. Replace cladding inside veranda?

A: Yes.

Reference Drawing 4/A2.0 - Building Section West-East Building Section and Sheet A1.1 - Room finish schedule:

“Remove existing cladding on the interior walls of the veranda. Provide new cladding to match exterior, as per specification.”

5. Who are the authorities having jurisdiction, and who will do building inspections?

A: TBD. Project Authority to confirm.

6. Contractors point out the soffit will likely have to be replaced as it will be hard to maintain its integrity when removing the cladding?

A: Remove existing soffit. Provide new soffit to match existing.

7. Who is responsible for clearing the rooms and spaces prior to construction?

A: Parks Canada will clear rooms of furniture and equipment where required for the work to be complete.

All other terms and conditions remain unchanged.
