AMENDMENT # 2

This amendment contains:

1) Revised Appendix 1 – Combined Price Form

(The revised appendix is available at the end of this document as well as in electronic form)

2) Technical Addendum #2

Actual addenda is related to electrical works added to wharf reconstruction project. It must be considered that all documents issued in present addenda are integral part of bidding process.

In summary, it is about supply and installation of:

- 2 service pedestals;
- light post

Related civil works include supply and installation of a concrete base for light post and the construction of a concrete pad where service pedestals are located. Detailed scope of work is presented in description of items in payment procedures.

Plans :

For electrical works, plans RM 1605C E01/02 et E02/02 are issued and. For related civil works, 6 plan extracts showing modification are issued.

Specification:

Division 26 of specification is added, which includes 14 sections.

Regarding section 01 29 00 – Payment procedure, article 1.1.6.1.5 is deleted and replaced by the following article:

Item 5 - Prefabricated concrete slabs (cribs 1 to 5)

- .1 This item will be paid following a global unit and will include the fabrication and installation of prefabricated concrete slabs in the works following the limits specified in the plan.**
- .2 The tendered price will include the cost for all labour, machinery, transportation and materials needed for the fabrication and final installation of prefabricated slabs. Materials include, among other thing, but are not limited to, concrete, rebar, formwork, lifting lugs and anchor bolts.**
- .3 This item should also include the installation of all steelworks, anchor bolts and lug to be embedded in concrete, concrete pads on slabs to receive electric pedestals, galvanizing of items where required, pouring, concrete curing and finishing, waterproofing surfaces and the final installation of the slabs on site, as well as any other work not specifically described, but required to carry out such work in accordance with the plans and specifications.**
- .4 The Contractor shall come up with an installation method that takes into account the capacity of new cribwork. See plan for more details.**

Regarding section 01 29 00, article 1.1.6.2.15 is added

Item 21 – Electric works

- .1 This item will be paid following a global unit and will include, without limitation , all of the electrical works presented on drawing E01 and E02 and the sections of the division 26 – Electrical. It also include the services center, the lighting system including the supply and the installation of the post light's concrete base, as well as any other work not specifically described, but required to carry out such work in accordance with the plans and specifications.
- .2 The tendered price will include the cost for all labour, machinery, transportation and materials needed for the realization of all the electrical works and related works.
