Q1: **5.1.1 Integrity Provisions - Declaration of Convicted Offences** In accordance with the Ineligibility and Suspension Policy (<http://www.tpsqc-pwgsc.gc.ca/ci-if/politique-policveng.html>), the Bidder must provide with its bid the required documentation, as applicable, to be given further consideration in the procurement process.

To fulfill the requirement we will need to enter the information found in section 17 of the Ineligibility and Suspension Policy correct?

Are there any other documents that we are to print and sign with respect to this?

A1: In accordance with the Ineligibility and Suspension Policy the bidder must declare any criminal offences that the directors or owners of the company have been convicted of.

Q2: **5.2.1 Integrity Provisions - Required Documentation** - We would follow the same process for as above for 5.1.1

A2: The bidder selected for contract award will be required to provide the names of the company directors or owners as specified in section 17 of the Ineligibility and Suspension Policy until requested by the Contract Authority.

Q3: **Annex "C" Insurance Requirements - page 46-48** Under Commercial General Liability Insurance, the letters under section 2 run from "A" to "M" then jumps to "Q" on the next page. Is there a section missing from the insurance requirements?

A3: The types of insurance addressed on items "n" through "p" are not required.
