**Q1.** Where do I enter extra hardware (connectors, supports, wall mounts etc.)? Do I add them to the Table 1 - Products?

**A1.** No, the information must be indicated in Table 6 - Bid Evaluation and contract Total at line 5: Hardware Total as per article 1.5 of Annex A-1 of SA (if applicable). This table is listed as optional to fill out however if you have extra hardware to add this is the only location that it can be added.

**Q2.** The amounts shown in the floor plans do not match what is being purchased in the tender.

**A2.** Yes, all furniture required for the project is shown on the floor plan however only those items listed in the tender are required as part of this bid. The items not shown in the tender are being purchased separately.

**Q3.** Is a separate installation bid required to move client's existing furniture into the swing space?

**A3.** The move and installation of client's existing furniture is not part of this tender.

**Q4.** New furniture shown for swing spaces - are components listed as new included in the quantities listed in the RFB tables, and to be integrated into phasing as project progresses?
