AMENDMENT 001

This amendment is raised to answer bidder questions raised during the solicitation process.

Question 1:

In the basis of payment spreadsheet price adjustment – ***P2010T section B.5.1 - P2010 T Paper - Price Adjustment – Bid*** sub section 2, shall this base transaction cost per Cwt. Field be the indicative of a particular manual delivery criteria or is this only a cost reflecting a portion of a particular manual delivery? If so can this delivery criteria be defined to develop the proper percent of unit pricing?

Response 1:

This clause serves to allow bidders to identify the cost of the paper required to produce the course materials as described in Annex “A” Statement of Work, and also the proportion of this paper cost in relation to the overall cost of production provided for in the unit price of each item and size of item as identified in the Annex “B” Basis of Payment. The result of this clause is that Canada will allow the transaction cost of paper to be adjusted during the contract period if the required documentation and basis for such an adjustment is provided.

Bidders must add/include the number of lines as necessary for each of the course materials and related items as described in Annex “A” Statement of Work and the pricing included in the Annex “B” Basis of Payment. If multiple lines are also required due to the different sizes of each item, then the Bidder must add in the required number of lines to reflect this.

As stated in *P2010 T Paper - Price Adjustment – Bid*, the following information must be provided for each of the lines submitted by the Bidder:

- The type of paper (text or cover)
- The weight lb. of the paper
- The base transaction cost per Cwt. of the identified paper
- The percentage of the unit price(s) for each item and size that the paper represents.
- The brand name of the paper and the paper supplier

Only the paper(s) and the percentage of the unit cost(s) submitted in the *B.5.1 - P2010 T Paper - Price Adjustment – Bid* will be considered for inclusion in the *B.5.2 – P2010 C Paper price adjustment - contract* clause of the Contract. If the Bidder does not complete this clause and submit it with the Bid, no Escalation Clause will be included in the Contract and no price escalation will be granted based on increased paper costs during the period of the Contract or any option periods.

Question 2:

Is section ***B.5.2 – P2010 C Paper price adjustment - contract*** to be completed for the initial bid as well, or is this to be completed after the contract is awarded?

Answer 2:

The ***B.5.2 – P2010 C Paper price adjustment - contract*** clause will be included in the resulting Contract based on the ***B.5.1 - P2010 T Paper - Price Adjustment – Bid*** submitted by the successful bidder in its bid.
