Description of the Requirement:

Employment and Social Development Canada (ESDC) requires information and technology services to support the department's program delivery mandate. This includes servicing business applications that support and streamline work processes, access data, and process millions of benefit-related transactions to address Canadians' needs. Accompanied by an integrated solution

for IT Services, ESDC requires support from professional IT resources to ensure continuity and quality of service in the following eight (8) broad domains:

1. Oracle SOA Suite

ESDC uses the Oracle SOA Suite of products to transform complex application integration into agile and re-usable service-based connectivity to speed time to deployment.

2. Oracle BMP Suite

The Oracle BPM Suite allows ESDC to enable business processes that deliver operational efficiency, business visibility, excellent customer experience, and agility to the enterprise.

3. Oracle WebCenter Portal

Oracle WebCenter Portal is ESDC's portal and composite applications solution to deliver intuitive user experiences to Canadians that are integrated with enterprise applications.

4. Oracle Identity Management

The Oracle Identity Management suite allows ESDC to simplify identity lifecycle management and secure access to its portal solution.

5. Enterprise Resource Planning (ERP) -SAP

ESDC's ERP is supported by PeopleSoft for Human Resource management activities.

6. Enterprise Resource Planning (ERP) - PeopleSoft

ESDC's ERP is supported by SAP for financial management activities.

7. Microsoft Dynamics CRM

ESDC uses the Microsoft Dynamics CRM suite of products to provide small and medium-sized case management solutions.

8. Project Management

ESDC's Project Portfolio Management Process (PPMP) is founded on the Stage-Gate® model, while its project management process is founded on Project Management Institute's (PMI) Project Management Body of Knowledge (PMBOK), with isolated pockets of the organization utilizing an Agile approach to project management and software development.

Each of category A.1, A. 6 and I.11 must have technical expertise on Oracle SOA Suite, Oracle BPM Suite, Oracle WebCenter Portal and Oracle Identity Management.

Each of category A.3, A.4 and A.5 must have technical expertise on ERP PeopleSoft, ERP SAP and Microsoft Dynamics CRM.

Category P.9 must have technical expertise on all of eight domains above.

The services will be performed within the National Capital Region. The Contractor will provide the services on an "as and when requested" basis. All requirements will be authorized through Task Authorizations issued in accordance with the Contract.
