## SOLICITATION AMENDMENT 006

*The following is raised to provide clarification in response to a question received and to extend the bid solicitation closing date from July 7<sup>th</sup>, 2016 at 2:00pm EDT to July 12<sup>th</sup>, 2016 at 2:00pm EDT.*

**Q17** M2/R1 has been amended by Amendment 005 released 23 June 2016 to now read "The Bidder must have demonstrated contract experience in supplying all of the following resource categories or similar resource categories, for the required minimum billable days per category, within the past seven (7) years prior to the Initial Solicitation Closing Date\*. The Bidder must demonstrate the required minimum billable days in a maximum of five (5) contracts. The Bidder must use the same set of five (5) contracts to demonstrate the billable days for both resource categories. Only the first (5) contracts identified will be considered.

Bidders who were previously not in a position to bid (due to the previous criteria being limited to 2 contracts only) can now consider a wider number of contract experience to meet the mandatory M2 due to this notable change. The current close date is challenging for Bidders who now wish to compete and are required to amass billable days information, confirm client contacts and obtain signed letters for M1 during the height of the summer holiday period when many clients are away. We respectfully request a 1 week extension to the current close date to react to this notable change in corporate mandatory and rated requirements and accompanying client reference requirements.
