**Answer 10:**

Yes the tests will be conducted in the manufacturers test kitchen or suppliers test kitchen depending on the situation. The test will be on only the larger of the units and would need to exhibit all functions as per RFP.

Yes representation from the Department of Defence will be present as per the annex with the documentation indicates, the Project Manager and Technical Authority at the very least will be present. No recording/documentation will be accepted in lieu of performance of evaluation.
