### **RESPONSE TO INQUIRIES DURING TENDER PERIOD**

**Question:** Need a clarification on one item. Solicitation #ET025-170316/A. On drawing L07 they refer to Bronze Plates. Is the Park supplying the plates? If not, do we need to order these from someone specific because they are customized? We can't find any information on this item. Are there any addendums and can you please forward them so I have not missed any?

**Answer:** Supply and installation of the bronze plates is the contractor's responsibility. Refer to Specification Section 05 50 00.2 and Landscape Drawings.

**Question:** Can we use the water from the tap?

**Answer:** Refer to specification section 01 51 00 Temporary Utilities.

**Question:** Nothing is shown on the drawings on what to do with the existing wall on the washrooms to receive new ceramic tiles. Please clarify?

**Answer:** Refer to revised Specification Section 09 30 13 CERAMIC TILING included in this addendum.

**Question:** Do you have a recommended manufacturer of viewfinder?

**Answer:** The viewfinders are to be custom built. It would be up to the contractor to determine the fabricator.

**Question:** Please provide dimension of the concrete pad and piles supporting the Amphitheater interpretive Sign.

**Answer:** Refer to Landscape and Structural drawings. There is no concrete pad at this location.

**Part 3.3.1 WALL TILE OVER EXISTING GLAZED CONCRETE BLOCK**

- .1 Install in accordance to TTMAC details.
- .2 Ensure that existing glazed concrete block wall surfaces have been cleaned and free of all oil, grease or other contaminants, which may affect bond.
- .3 Apply primer to prepared glazed block surface in accordance to manufacturer's specifications.
- .4 Apply thin set mortar over primed surface. Ensure that surface mortared surface is smooth and level, ready to accept new wall tiles. Install mortar in accordance to manufacturer's specifications.

**Item No. 2:** Refer to Specification Section 08 71 00 DOOR HARDWARE. Refer to 3.6 SCHEDULE. For Group 1:

**DELETE:** " Stop Glynn-Johnson 104S C32D".

**ADD:** Floor Stop GSH 209 , 26D (Finish).
