## **PART 1 - GENERAL INFORMATION**

### **1.1 Requirement**

To provide 120 each of ballistic helmets and goggles to the Correctional Service of Canada, Kingston Ontario in accordance with Annex A - Requirement.

### **1.2 Debriefings**

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

### **1.3 Trade Agreements**

The requirement is subject to the provisions of the North American Free Trade Agreement (NAFTA), and the Agreement on Internal Trade (AIT)."

## **PART 2 - BIDDER INSTRUCTIONS**

### **2.1 Standard Instructions, Clauses and Conditions**

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the *Standard Acquisition Clauses and Conditions Manual* (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The 2003 (2016-04-04) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

### **2.2 Submission of Bids**

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

### **2.3 Enquiries - Bid Solicitation**

All enquiries must be submitted in writing to the Contracting Authority no later than 10 calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

## 2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

## PART 3 - BID PREPARATION INSTRUCTIONS

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that Bidders follow the format instructions described below in the preparation of their bid:

- (b) use a numbering system that corresponds to the bid solicitation.

- 2) use an environmentally-preferable format including black and white printing instead of colour printing, printing double sided/duplex, using staples or clips instead of cerlox, duotangs or binders.

## PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

### 4.1 Evaluation Procedures

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

#### 4.1.1 Financial Evaluation

The Bidder must submit its offer in accordance with Annex B, Basis of Payment.

**4.1.2** Financial bids will be evaluated on an aggregate basis based on the estimated usages provided in Annex "B", Basis of Payment.

**4.1.3** The Quantity in (column A) will be multiplied by the Unit Price in (column B) and the resulting total of both columns will be the firm price in (column C).

The sum total of both line items 1 & 2 in column C will be added together to determine the total evaluated price.

**4.1.4** Bidders must submit pricing in accordance with the Basis of Payment, Annex "B", attached herein, as firm all inclusive pricing or their bid will be considered non-responsive and will be given no further consideration.

**4.1.5** If the Bidder's pricing in its response to this RFP is not in Canadian currency, it will be converted to Canadian currency using the appropriate nominal exchange rate on the closing date as posted on the Bank of Canada Website located at:

### 4.2 Basis of Selection

A bid must comply with all requirements of the bid solicitation to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract.

## PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Unless specified otherwise, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

## 5.1 Certifications Required with the Bid

## ANNEX A

### REQUIREMENT

**Correctional Services Canada requires the supply and delivery of 120 Ballistic Helmet and 120 Ballistic Goggles. The items must meet the following Minimum Technical Specifications.**

Item (1) Level 3A Ballistic Helmet for Correctional Service of Canada must meet the following Minimum Technical Specifications:

- Helmet is for use by specialized personnel and must be lightweight with minimal interference to visual and hearing functions.
- Helmet must be compatible with all available attachable communication equipment, Gas Masks (under the helmet) and Night Vision Goggles.
- Must have NVG Mount Options: 1 hole, 2 holes, 3 holes
- Helmet must be constructed from the latest advanced Ballistics composites offering maximum protection.
- Must have a harness design that provides a stable and comfortable fit with individual adjustment capacities.
- Must have a four point harness design that is anchored to the shell by ballistic resistant bolts.
- Harness must be Matte Black in colour.
- Harness must be able to be easily removed to afford cleaning or replacement and must not require specialized cleaning, machine wash preferred.
- Helmets must be Matte Black in colour with Individual identifier numbers on the rear of the helmet.
- Helmet must be high cut style
- Helmet must be certified to NIJ 0106.01 for Ballistic protection to level IIIA standard.
- Helmet must be certified for a five year lifespan (shelf life).
- Helmet must have the capacity to adapt to integrated communications

Item (2) Ballistic Goggles for Correctional Service of Canada must meet the following Minimum Technical Specifications

- Must have indirect venting.
- The lens colour must be clear/smoke grey and the lens coating must be anti-fog and scratch resistant and made with a polycarbonate material.
- The ballistic goggles frame must be constructed with thermo plastic rubber and the colour of the frame must be black.
- The ballistic goggles must provide 100% ultraviolet protection.
- The ballistic goggles must include a 2 speed fan, speed sleeve, face padding, carrying case, 2.8mm clear & smoke grey lenses and one AA battery.
- The ballistic goggles must meet the following Standards - ANSI Z87.1-2010, MIL-DTL-43511D, CE EN 166.
