2.2 Submission of Bids

2.2.1 Improvement of Requirement During Solicitation Period

Should bidders consider that the specifications or Statement of Work contained in the bid solicitation could be improved technically or technologically, bidders are invited to make suggestions, in writing, to the Contracting Authority named in the bid solicitation. Bidders must clearly outline the suggested improvement as well as the reason for the suggestion. Suggestions that do not restrict the level of competition nor favour a particular bidder will be given consideration provided they are submitted to the Contracting Authority at least 7 days before the bid closing date. Canada will have the right to accept or reject any or all suggestions.

Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

ANNEX "A"

STATEMENT OF REQUIREMENT

1. PURPOSE

The Marine Fish Section in the Science Branch within the Department of Fisheries and Oceans in the Gulf Region, wishes to purchase a 120 kHz acoustic echo-sounder system including the calibration sphere to conduct random stratified acoustic surveys of herring on six fall spawning grounds.

The purpose of this document is to provide the general and specific requirements for this purchase.

2. DESCRIPTION OF GOODS AND SERVICES

2.1 Background

The Marine Fish Section in the Science Branch within the Department of Fisheries and Oceans in the Gulf Region conducts the scientific assessment of herring in the southern Gulf of St. Lawrence. An important component of this assessment has always been hydro-acoustic surveys. The information from these types of surveys are incorporated into the population model for herring and are therefore very important to the assessment of this species.

Historically herring commercial vessel surveys have been conducted using the Femto DE9320 acoustic echo-sounder which uses a 120 kHz single beam transducer. As Femto equipment is rapidly becoming obsolete, we need to transition our equipment to new acoustic sounders to manufactures with proven longevity and track records.

As we transition away from Femto equipment we will need an echo-sounder system that produces comparable survey results. We currently have nine (9) DE9320 and as we migrate to a new manufacturer we will be dealing with both types of units conducting surveys in a given year therefore they need to be comparable.

The option for the 120 kHz split beam transducer is requested as herring surveys are best conducted using 120 kHz. Our current technology uses 120 kHz transducers and our annual scientific acoustic survey uses a 120 kHz split beam transducer. The 38/200 kHz transducer is single beam and it is unclear if the 200 kHz would be compatible with past surveys. The 38 kHz is also not ideal for the shallow water of the Gulf of St. Lawrence. Furthermore, calibration to a single frequency transducer is much simpler than for a dual frequency unit.

The options that the transducer will be hull mounted is requested as the echo-sounder system will be used on commercial gill net fishing vessels and it is necessary to not impede with the fishing activities of the vessels.

The units will be placed on commercial vessels so ease of use and limited ability to alter settings is important so that the fish harvesters cannot and do not have to alter the computer program.

The option that the data collection format must be compatible with Echoview® is requested as Echoview® is the software used to analyze the acoustic data collected. The data collected by the acoustic sounder must be in a format that can be easily analyzed by this software.

2.2 General Information:

The required system consists of one (1) Split Beam Echo-Sounder System, one (1) transceiver / processing unit, one (1) 120 kHz Split Beam Transducer, and one (1) calibration sphere.

3. MANDATORY SYSTEM REQUIREMENTS

3.1 Minimum Essential Requirements:

Any interested supplier must demonstrate by way of Annex "C" that its products meet the following specifications:

1. The split beam echo-sounder system must operate at 120 kHz.
2. The split beam echo-sounder system must provide beam width from 6° x 6° to 7° x 7°.
3. The system must have a sounding depth range from 1 m to 200 m.
4. The transducer must be hull mounted.
5. The data collected from the echo-sounder system must be able to integrate with the third party software Echoview®.
6. The data collected must be comparable with current acoustic sounders, Femto DE9320.
7. Easy operation with intuitive user interface.
