QUESTIONS AND ANSWERS

Question 1. Please refer to page 33, 8. **RCMP Support:** states that the Physician will have access to two examination rooms however the Statement of Work in Annex A focuses on file review. Can you please clarify if this Physician will be conducting assessments/physicals on patients, or reaching conclusions by evaluating charts and medical records conducted by other professionals?

Answer 1. The Senior occupational health Physician's main task will be to conduct the revision of medical files however in the event that the designated doctor is either on leave/vacation the Senior occupational health Physician may be asked to provide medical examinations.

Question 2. Please refer to page 33. 10. **Language Requirements:** states that the candidate needs to be fluent in both languages for reading, writing and speaking. The Medical forms shared in Appendix 1, page 34-52 are all bilingual forms. Please clarify if the Physician could be bilingual at the spoken level, but not bilingual at the written level.

Answer 2. The Physician must be able to read, write, speak and understand at an Advanced Level in both official languages.

Question 3. Please refer to Annex C, page 55-57 outlines the required security clearance as RCMP Reliability Status. At what stage should the clearance be initiated for the prospective Physician? How does the bidder go about initiating this clearance? How long does an RCMP Reliability Status clearance usually take to come in? Will that affect start time on the contract?

Answer 3. Only the winning bidder will be required to pass a security clearance and the contracting officer will supply all required documents. The contract will not be awarded until the clearance is received from the personnel security section of the RCMP which generally takes between 6 to 12 weeks.
