## **PART 1 - GENERAL INFORMATION**

### **1.1 Security Requirements**

There is no security requirement associated with this solicitation.

### **1.2 Requirement**

DND, CFB Shearwater, NS, has a requirement for two (2) Type 2 Explosive Storage Magazines, as fully detailed in Annex A.

### **1.3 Debriefings**

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

### **1.4 Trade Agreements**

This requirement is subject to The Agreement on Internal Trade (AIT) and the North America Free Trade Agreement (NAFTA).

## **PART 2 - BIDDER INSTRUCTIONS**

### **2.1 Standard Instructions, Clauses and Conditions**

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the *Standard Acquisition Clauses and Conditions Manual* (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The 2003 (2016-04-04) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

### **2.2 Submission of Bids**

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

### **2.3 Enquiries - Bid Solicitation**

All enquiries must be submitted in writing to the Contracting Authority no later than seven (7) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is

eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

## 2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Nova Scotia.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

## PART 3 - BID PREPARATION INSTRUCTIONS

### 3.1 Bid Preparation Instructions

Canada requests that Bidders provide their bid in separately bound sections as follows:

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that Bidders follow the format instructions described below in the preparation of their bid:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to the bid solicitation.

#### Section I: Technical Bid

In their technical bid, Bidders should explain and demonstrate how they propose to meet the requirements and how they will carry out the Work.

#### Section II: Financial Bid

Bidders must submit their financial bid in accordance with the Basis of Payment. The total amount of Applicable Taxes must be shown separately.

#### Section III: Certifications

Bidders must submit the certifications and additional information required under Part 5.

## **PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION**

### **4.1 Evaluation Procedures**

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

#### **4.1.2 Financial Evaluation**

The price of the bid will be evaluated in Canadian dollars, Applicable Taxes excluded, FCA Free Carrier, (supplier plant), Canadian customs duties and excise taxes excluded, where applicable.

### **4.2 Basis of Selection**

A bid must comply with the requirements of the bid solicitation and meet all mandatory technical evaluation criteria to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract.

## **PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION**

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Unless specified otherwise, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

## **Annex A Requirement**

### **Objective:**

DND, 12 Wing Shearwater has a requirement for the supply of two (2) portable explosive storage magazines (class 2) to increase 12 Wing explosive storage capacity to up to 800kg of Net Explosive Quantity (NEQ).

### **Scope:**

To procure (2) two 10'L x 8'W x 8'H magazine to store C2A2 Marker Location Marine C2A2 (HC 1.340), LUU 2B/B Series Parachute Flares (HC 1.33G), ASD 3627 Counter measure flares (HC 4.2) and 7 .62 mm ball (HC 1.4S) ammunition for the C6 GPMG. Magazine must have explosion-proof heating and lighting and must have a 2 high security weatherproof hasp.

To procure (2) two explosion proof heating source and (2) two explosive proof lighting with hardware for the magazine.

Not included in scope is building of concrete pad and electrical hook-up that will be completed by Formation Construction Engineer (FCE).

### **Minimum Mandatory Technical Criteria:**

- a. Security: door must be lockable by a 2 high security weatherproof hasp.
- b. Contractor is to deliver (2) two ammunition magazines of minimum external size 10'L x 8'W x 8'H and explosion proof heater, lighting and attached hardware.
- c. Building standard: Magazines must be approved for storage of ammunition by NDHQ/DAER and meet the requirements of C-09-005-002/TS-000 Ammunition and Explosive Safety Manual - Storage and Facility Operations and C-09-153-005/TS-000 Ammunition and Explosives Safety Manual - Storage and Facility Operations, including but not limited to, floor load capacity, wall resistance and grounding system.
- d. The 10'L x 8'W x 8'H magazine must have explosion proof electrical heating and lighting that meet the requirements of C-09-005-002/TS-000 Ammunition and Explosive Safety Manual - Storage and Facility Operations and C-09-153-005/TS-000 Ammunition and Explosives Safety Manual- Storage and Facility Operations. Air conditioning is not required.
- e. Magazine must be vented.
- f. Magazine must be movable either by crane or forklift.
- g. Supplier must identify the lifting points for the magazine.
- h. Both magazines must be identical.
- i. Interior and exterior must be constructed in such a manner to be free of sharp edges, burrs and slivers.
