Q1) If churning is required to advance the piles to required tip elevations, is the Contractor to allow for the costs to perform this work in Bid Item 3 Catamaran Installation, or will the Contractor get paid for all Churning activities under Bid Item 4 Additional Pile Driving?

A1) Bid amount for churn/drill socket activities will be provided in Bid Item 4 Additional Pile Driving on the Combined Price Form. No cost for churning activities is to be included in Bid Item 3 Catamaran Installation.

Q2) On the combined price form for the Catamaran installation does that include the installation of the piles and is the pile length based on the drawings (drawing 003)and will any additional length be paid as an extra ?, is it also the contractor risk that there may be bedrock and the pile is to be advanced as per the chart on drawing 003 or will advancement into bedrock be paid as a separate item under number 4 of the combined price form

A2) Please refer to Section 01 11 00 of specifications for description of work included under Catamaran Installation. Please refer Table 1: Pile Table on drawing 216104-003-A PILE WELL & BOLLARD for pile lengths. See Answer to **A1** of this Amendment for advancement into bedrock.

Q3) In the specs and drawings there are 3 different wall thickness for the pile that conflict can you confirm the wall thickness that is required for the piles that are to be installed ?

A3) Pile wall thickness is 19.1mm

Q4) In regards to the pile size for this project, in the summary of work section 01 11 00 page 6 - .2 it states piles are 19.1 x 762 in section 31 62 16.19 page 33 Materials 2.1 it states 762 x 12.7 thick. Please confirm size.
