2.2.1 Improvement of Requirement During Solicitation Period

Should bidders consider that the specifications or Statement of Work contained in the bid solicitation could be improved technically or technologically, bidders are invited to make suggestions, in writing, to the Contracting Authority named in the bid solicitation. Bidders must clearly outline the suggested improvement as well as the reason for the suggestion. Suggestions that do not restrict the level of competition nor favour a particular bidder will be given consideration provided they are submitted to the Contracting Authority at least seven (7) days before the bid closing date. Canada will have the right to accept or reject any or all suggestions.

2.3 Former Public Servant

Contracts awarded to former public servants (FPS) in receipt of a pension or of a lump sum payment must bear the closest public scrutiny, and reflect fairness in the spending of public funds. 2.4 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than seven (7) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is

eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.5 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in **Prince Edward Island**.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

Annex "A" Statement of Work

TITLE:

Supply water treatment equipment at the Charlottetown Laboratory.

BACKGROUND:

The Charlottetown Laboratory is currently accepting bids for one (1) replacement reverse osmosis system with both electrodeionization (RO EDI) and ultraviolet (UV) units, the new system will have a minimum production rate of 9.5 gallons per minute. This equipment is required to supply low conductivity water to the boiler plant and deionized water to the laboratories. The Charlottetown Laboratory supports plant health testing and research services in support of the Canadian potato industry. The facility also houses the Aquatic Animal Pathogen and Biocontainment Laboratory operated by the Department of Fisheries and Oceans.

OBJECTIVE:

Supply the equipment to replace one (1) WMQ 900 Zenon water treatment system, resin type deionized system and Aquafine UV CSL-4R system at the Charlottetown Laboratory. Note: All equipment must meet CSA approval or equivalent

SCOPE:

The Supplier is to provide all the equipment required to complete the installation of the new water treatment system at the Charlottetown Laboratory. The new reverse osmosis system HMI controller is to be capable of complete integration with new and existing components that are to remain including the storage tanks, distribution pumps, and control valves. The HMI controller must be digital and provide a method of connection for field devices. The field devices will include pumps, valves, tank level control and sensors. The proposed equipment must have the following design parameters:
