## **QUESTIONS AND ANSWERS**

### **QUESTION 1**

We note that the document was released on the 30<sup>th</sup> June 2016 with a closing date of the 11<sup>th</sup> August 2016, which gives a total of 6 weeks to respond to the request. We also note that in section 2.3 Treatment of Responses; it is stated that:

"Canada may, at its discretion, review responses received after the RFI closing date".

Considering the detailed and complex content of the RFI Nature and Format of the responses (section 13); can we request an official extension to the closing date for this request for information, to give interested parties time to prepare a comprehensive response. We request this so that we can be certain that any effort expended in putting together a response can be guaranteed to be considered and reviewed, rather than at Canada's discretion.

### **ANSWER 1**

Canada is not willing to consider an extension to the RFI closing date at this point in time.

### **QUESTION 2**

In order to best help Canada meet its objectives with this RFI, I am writing to request a 30-day extension in the closing date for the ePassport Solution RFI that was released on June 29, 2016 under Solicitation Number B7021-170031/A.
