This Amendment #001 is raised to address questions, revise the General Instructions to Offerors, and to remove SC02 Limitation of Liability from the Supplementary Conditions.

### **Questions and Answers**

**Q1.** Regarding Page 5 - GI02 (2014-03-01) Completion of Offer – portion reading: “submitted on the Offer and Acceptance Form provided through the Government Electronic Tendering Service (GETS)”. Can you tell me where to access this form?

**A1.** The Bid and Acceptance Form is actually the Price Proposal Form found under Appendix 4 in the solicitation. The General Instructions will be revised to say the Price Proposal Form.

**Q2.** Regarding page 34 - Appendix 4 – Price Proposal Form – Sec. 4 Sub. 4.1 – Unit Price Schedules – Rates a), b) & c). Can you tell me why there are already numbers entered in the Estimated Hours/Quantity cells of these forms? Are we to strike these figures out and enter our own estimates based on our own proposal?

**A2.** The numbers are our estimated hours/quantity for each class of labour, material, plant and are used as a basis for evaluation. Please do not strike out these figures. As per GI02, any alteration to the pre-printed or pre-typed sections of the Offer and Acceptance Form, or any condition or qualification placed upon the offer may be cause for disqualification. Contractors are to fill out the unit price and estimated total price columns and all the other blank spaces on the form.

**Q3.** Regarding page 41 – Annex A – Security Requirement Check list (SRCL). Are we required to provide any further information to the copy of the completed SRCL on the next 4 pages or is this document for our information only?

**A3.** No, the SRCL is for reference only.

### **Revision of General Instructions to Offerors**
