**This amendment has been raised to respond to the following questions:**

**Question #1:**

What laydown space is available and is the contractor required to prep the areas?

**Answer #1:**

The laydown area is identified on the location plan (See Drawing G-02). Any laydown preparation will need to be completed by the contractor.

**Question #2:**

Is the Wastewater Treatment Plant contractor responsible for paving the path all the way to the bridge?

**Answer #2:**

The contractor is responsible for the paving as shown drawing C-01.

**Question #3:**

Is there a weight restriction on the path that leads from the west parking lot to the WWTP?

**Answer #3:**

No.

**NOTE:** The WWTP contractor will be required to assume maintenance responsibility of the pathway after completion of installation of granular base (work by others) until it is paved under this contract.

**NOTE:** All contractors and subcontractors working on this project will need to obtain a business licence from Parks Canada, Jasper National Park for the work. The business licencing process will include passes. See specifications (01 10 00) for information on obtaining a business licence.

**NOTE:** The road leading up to the Miette Hot Springs site is maintained in the winter. However, it is very low on the priority list and is not cleared down to the pavement. The contractor will not always have access to the site following a snow storm / event and should plan accordingly. See specifications (01 55 00) for additional information on access restrictions.

**NOTE:** The contractor will be responsible for coordinating with the power and telephone utility companies to move/maintain these services. The utility transformer is to be changed out under this contract and at no time can this leave the main pool building or any of the residences without power for extended periods.

**NOTE:** The road to Miette Hot Springs is closed to public from Thanksgiving Day long weekend to the beginning of May each year. During this period it is expected that only Parks Canada Maintenance staff will be required to pass through the work site to access facilities up stream such as the hot springs source and domestic water intake.

The pathway that leads from the west parking lot towards the hot springs source will be open to public from the beginning of May to the Thanksgiving Day long weekend each year. The contractor will be responsible for mitigating risk to the Pedestrians using the pathway and shall ensure that the pathway is open during this time. Pedestrian traffic control is the responsibility of the contractor.
