SCOPE OF WORK / DELIVERABLES:

The work under this contract shall include the supply of equipment, labour and materials for the performance of all work as required by the Contract Documents. All replaced items, cut-offs and waste material shall be disposed by the contractor.

The work includes the demolition and disposal of the existing timber log breakwater in Fanny Bay, the supply of all material to install a new owner supplied floating catamaran breakwater and a new contractor supplied log breakwater as shown on the drawings.

The work generally consists of, but is not limited to the following items:

1. Mobilisation/Demobilisation.
2. Demolition.
3. Delivery, Modification and Installation of the New Catamaran, Mooring Piles and associated hardware.
4. Supply and Install of new 18m log breakwater compete with mooring piles and associated hardware.

The following materials shall be supplied by the Owner and are available for retrieval by the Contractor from the **Fanny Bay Harbour** following award:

1. Seven (7) anodes and cable to be installed on the steel piles.
2. Sixteen (16) anodes and cable to be installed on the catamaran breakwater.
