This Solicitation amendment is raised to answer questions received from Bidders.

QUESTION 1

I would like to check whether it is possible to remove the two classifications (P.13 Independent IT Project Review Team Leader and P.14 Independent IT Project Reviewer) so that we can respond to this solicitation.

We have the references required for us to qualify for these positions and, in fact, we were intending to update our profile on TBIPS at the time of the next upgrade, which will be done by the end of 2016. Unfortunately, at the present time, we do not have these classifications.

QUESTION 2

Would the Crown consider amending C.M2 to allow bidders to reference contracts for which the services were provided under a maximum of 5 contracts per resource category?

ANSWER 2

QUESTION 3

3.1. For Corporate Mandatory requirement C.M2, Billable Days, Resource Categories, Independent IT Project Review Team leader – Level 3 and Independent IT Project Reviewer – Level 2, would the crown consider relaxing the number of billable days required as these are relatively new TBIPS categories introduced to the TBIPS Supply Arrangement in a more recent refresh, and most bidders will not have garnered the amount of experience requested in such a short window of time as the typical project duration for these specialized types of resources tend to be less than 20 days or alternately drop the categories entirely from the billable days requirement?

3.2. Can existing TBIPS JV Companies (Company A and Company B in JV) pool their billable days to meet C.M2/C.R1 as a demonstration of each part of the JV's strengths/contracts – that is, contracts for Company A and contracts for Company B can be used to meet C.M2/C.R1 as long as Company A and Company B are responding as an already established JV under TBIPS?
