This Amendment #2 is being issued to answer questions received against this solicitation. There was an error in the solicitation notice indicating the closing date of October 21st 2016. This has been amended to read October 25th 2016.

A Requirements Guide has been attached to this solicitation for assisting with Bid preparation. It is strictly for information purposes.

Q51. Can the PDF documents be provided in their native format (Excel or Word)?

A51. There are several commercially available software products that can assist with PDF conversion. No other format will be provided.

Q52. Is there a limitation on the number of Bidder representatives that can attend each respective site visit?

A52. Two representatives per company

Q53. Please confirm the required security clearance level for the site visits.

A53. The content of the visit will be "unclassified". Therefore Canadian citizens will not require a security clearance or Visit Clearance. The Unit will require a list of all names at least ten days before the visit however to arrange escorted access. Foreign Nationals will however require Reliability status.

Q54. If a Bidder's representatives are comprised of foreign nationals, i.e. US citizens, please confirm that they are required to have the equivalent security clearances required by Canada.

A54. Foreign Nationals must have a minimum of reliability status (in their countries) and companies must submit a visit clearance request through each Foreign National's embassy to Canada. (IE US Citizens thru US Embassy, Swedish citizens thru Swedish embassy, Etc) This process could take up to 35 business days.
