### AMENDMENT #003

This amendment solicitation is raised to answer questions from the industry.

To answer questions #11 to #21 from the industry:

#### QUESTION 11:

Would the crown accept the following categories as a response to MT1.1 in support of supply chain management services as these highly complex services encompasses all Project tasks involving Supply Chain and related technical services management? A synopsis is as follows:

*The CF 18 Fighter is comprised of numerous systems which ensure the aircraft functions properly, control the aircraft's movement, provide threat detection and avoidance capabilities, allow for loading and control of munitions, and provide aircraft systems' performance and maintenance information. To ensure the timely availability of all of these systems, a wide range of professional services are needed to provide engineering support, technical and maintenance support, resource utilization monitoring, integrated logistics support, configuration management, information systems management, publications management, and administrative and clerical support. These professional services are grouped under three (3) in-service systems support areas, which are referred to in this SOW as Organizational Groups. They include:*

a. Group 1: *Technical Support Services:*

- One (1) Senior Engineer;
- One (1) Junior Engineer;
- One (1) Life Cycle Manager;
- Four (4) Technical Data and Pubs Managers;
- Two (2) Technical Publications Information and Administrative Services;
- Two (2) Junior Project Managers
- One (1) Intermediate Software Specialist.

b. Group 2: *Life Cycle Management:*

- Eleven (11) Life Cycle Managers;
- One (1) Procurement Specialist
- One (1) Intermediate Software Specialist

c. Group 3: *Electronic Warfare Systems Engineering and Technical Services*

- One (1) Life Cycle Manager.

#### ANSWER 11:

Based on the information provided, the crown would accept these categories as part of Supply Chain Management. The crown recommends further details on the project scope when submitting responses.

**QUESTION 12:**

In order to increase the number of bids received and allow for more completion, would the crown reduce the requirement of MT1.1 to providing 1 project (vice 2) and involving 8 resources (vice 10) in response to MT1.1?

**ANSWER 12:**

The Crown has reviewed the request for the requirement of MT1.1 and it will remain unchanged.

**QUESTION 13:**

In Part 2 paragraph 2.3 are these certifications to be provided in Section III: Certifications of Part 3?

**ANSWER 13:**

As stated in Part 3 - BID PREPARATION INSTRUCTIONS, paragraph 3.1 Bid Preparation Instructions, Section III: Certifications:

*In Section III of their bid, bidders should provide the certifications required under Part 5 and, as applicable, any associated additional information.*

**QUESTION 14:**

In Part 5 paragraph 5.1.1 and 5.2.2 - Please clarify what is required in this section. In previous bids a form was provided for the certification / information.

**ANSWER 14:**

As stated in Part 5 paragraph 5.1.1 Integrity Provisions - Declaration of Convicted Offences and paragraph 5.2.1 Integrity Provisions – Required Documentation, the Bidder must provide with its bid the required documentation, as applicable in accordance with the Ineligibility and Suspension Policy (<http://www.tpsgc-pwgsc.gc.ca/ci-if/politique-policy-eng.html>). Detailed information and form(s) are provided in the aforementioned link.

As stated in Part 5 paragraph 5.2.2 Federal Contractors Program for Employment Equity - Bid Certification, the Bidder must provide the completed Federal Contractors Program for Employment Equity certification in Attachment 1 to Part 5, section 1.

In Part 7 paragraph 7.1.2 – If work is only authorized under a TA / 626 how will work performed by the Project Team Leader, LCMS and MMS be authorized? Is their work (6.1, 6.2 and 6.3 of the SOW) to be included in each audit task or will a management TA / 626 be authorized?

**ANSWER 16:**

A DND 626 Task Authorization (TA) for the Project Team Leader will be authorized.

**QUESTION 17:**

In Part 7 paragraph 7.3.1, does the "NOTE" refer to the Appendix A within the SRCL or is a further document expected to be generated?

**ANSWER 17:**

The "NOTE" does refer to the Appendix A to Annex C, SRCL Supplemental Security Guide.

**QUESTION 18:**

The Appendix A to Annex C (SRCL) provides the required security clearance for each position. Please confirm that each position (individual) will also need to be authorized or required screening under the Controlled Goods Program (CGP).

**ANSWER 18:**

**QUESTION 19:**

In ATTACHMENT 1 TO PART 4, TECHNICAL CRITERIA, the MT 5.1 requirement states "working in the Public Sector as a Life Cycle Management Specialist". Please confirm this is not restricted to just working in the Public Sector but includes working under contract for Canada as a Life Cycle Management Specialist.

**ANSWER 19:**

In ATTACHMENT 1 TO PART 4, TECHNICAL CRITERIA, the MT5.1 requirement "working in the Public Sector as a Life Cycle Management Specialist" is not restricted to just working in the Public Sector but includes working under contract for Canada as a Life Cycle Management Specialist.

**QUESTION 20:**

In ATTACHMENT 1 TO PART 4, TECHNICAL CRITERIA, the MT5.3 states "Bidder must demonstrate that the proposed resource possesses a certificate or a diploma in any technical studies/program field offered by a provincially recognized post-secondary relevant technical institution". Does Canada consider military or government technical training equivalency as acceptable?

**ANSWER 20:**

Yes, military or government technical training equivalency is acceptable.

**QUESTION 21:**

In ATTACHMENT 1 TO PART 4, TECHNICAL CRITERIA, the MT3 Site Manager – How many Site Managers must the bidder propose to demonstrate compliance with the mandatory requirements?
