This Amendment #4 is being issued to make changes to the Arctic Offshore Patrol Ship (AOPS) and Joint Support Ship (JSS) In-Service Support RFP and to answer questions received against this solicitation.

Part 1 Amendments to the RFP

1. Attachment 1 to Part 4 – Item 1B: Technical Plans, No. 1, Preliminary Program Management Plan, Assessment Criteria

Delete in its entirety: The Bidder will be evaluated on their Preliminary Program Management Plan for the AJISS contract in accordance with DID AJISS-PM-001.

A written submission not to exceed 30 pages in total is required.

The submission should include a summary Program Management Plan Description that should describe concepts, processes and integration of how the Bidder will manage the AJISS program. The submission will include the Data Management Support Plan, Performance Management Plan, Configuration Management Plan, Disposal Management Plan and Contract Close-out Plan. The submission should not include the specific Start-Up Plan, Transition Plan and Risk Management Plan, as they are evaluated separately.

Insert in its entirety: The Bidder will be evaluated on their Preliminary Program Management Plan for the AJISS contract in accordance with DID AJISS-PM-001.

A written submission not to exceed 50 pages in total is required.

The submission should include a summary Program Management Plan Description that should describe concepts, processes and integration of how the Bidder will manage the AJISS program. The submission will include:

- 1. Preliminary Data Management Support Plan in accordance with DID-AJISS-PM-004;
- 2. Preliminary Performance Management Plan in accordance with DID-AJISS-PM-008;
- 3. Preliminary Configuration Management Plan in accordance with DID-AJISS-PM-007;
- 4. Preliminary Disposal Management Plan in accordance with DID-AJISS-PM-010; and.
- 5. Preliminary Contract Close-out Plan in accordance with DID-AJISS-PM-011.

The submission should not include the specific Start-Up Plan, Transition Plan and Risk Management Plan, as they are evaluated separately.

Delete in its entirety: The Bidder will be required to submit a component of their Preliminary Service Delivery Project Plan for the preparation and execution and completion of a four week AOPS Short Work Period, in accordance with DID-AJISS-TSM-003.

A written submission not to exceed 10 pages in total and should provide the methodology on how the Bidder will execute the work.

Insert in its entirety: The Bidder will be required to submit a component of their Preliminary Service Delivery Annual Operating Plan (SDAOP) in the form of a Preliminary Service Delivery Project Plan (SDPP) for the preparation and execution and completion of a four week AOPS Short Work Period, in accordance with DID-AJISS-TSM-003.

A written submission not to exceed 10 pages in total and should provide the methodology on how the Bidder will execute the work.

Part 2 Questions and Answers

Q55. Will the holdback of the Performance Management Fee be limited to each contract year and not carry-over into a new contract year?

A55. In accordance with Part 7 - Resulting Contract Clauses 7.8.3 a) ii, performance holdback, if applied to payments made by Canada, will continue to be applied until the Contractor's performance, as measured against the agreed KPI's improves. There is no limitation by calendar year implied or intended.

Q56. Please confirm that, in addressing these plans, bidders are required to follow the DIDs for each named plan, specifically:





- DID-AJISS-PM-004 for the Data Management Support Plan;
- DID-AJISS-PM-008 for the Performance Management Plan;
- DID-AJISS-PM-007 for the Configuration Management Plan;
- DID-AJISS-PM-010 for the Disposal Management Plan; and
- DID-AJISS-PM-011 for the Contract Close-out Plan.

A56. Confirmed; bidders are required to follow the DIDs for each named plan. (See Amendment 1)

Q57. Please confirm that page limitations, if specified, in the RFP evaluation requirements, exclude introductory pages such as the title page, table of contents, revision page, list of acronyms, etc.

A57. Negative. If introductory pages such as the title page, table of contents, revision page, list of acronyms, etc., are included, they will be considered part of the total page count.

Q58. In PWS-335 and in various other PWS statements the term "origin of the vessel" is used (e.g., "The Contractor must perform SWPs in the respective Naval Dockyards and DWPs in the origin of the vessel of each ship.")

Could Canada provide a definition of the term "origin of the vessel"?

A58. Refer to the glossary attached to the PWS as, AJISS PWS Dictionary V3.0 PDF page 22/31

Q59. What is the intended use of the word "company" with respect to number of allowable attendees to the shipyard visit?

A59. The intended use of the word "company" is not synonymous with "Bidder". It is permissible to send 2 representatives from each company that may comprise a Bidder's Team. For example, "Company A" and "Company B" may or may not be within a bidding team. Both companies can send 2 representatives each.
