Questions:

"We have reviewed with Transport Canada the need to have an AMO certification to satisfy the work within this RFP. We have been told it is not required. We also believe the items within the RFP do not qualify as Aeronautical Products as per the TAM and therefore we respectfully request the mandatory AMO certification at bid close, be removed from the RFP.

As per the SACC clauses within the RFP, clause D5540C says the contractor need not be registered with ISO, but meet the requirements thereto. We request that the Mandatory ISO certification be changed to "ISO certification or equivalent as per D5540C"

Answers:

"The requirement for the R&O contractor to be AMO certified has been a repetitive mandatory work and contract requirement three additional times since 1999.

This is not an aircraft manufacturing or aircraft maintenance contract, from a civilian airline, nor does this have anything to do with civilian sport; this is a Department of national Defence (DND) contract for DND Lifesaving equipment which is worn by Canadian Forces Personnel.

While some NATO Armed Forces may not require stringent quality assurance for the repair and overhaul and recertification of their particular equipment DND does.

While ISO certification means repetitiveness, it does not necessarily mean consistent quality assurance and cannot be revoked by governing body/federal regulator.

AMO certification as granted by Transport Canada does mean the company it has been granted to, has in place the quality assurance standards, and practices required for particular lifesaving equipment and maintains those quality standards, or has them revoked.

Having this mandatory certification which guarantees the highest quality assurance practices is only fair to our Canadian Forces men and women who lives depend on this lifesaving equipment daily and for it to function as intended each and every time it is needed.

As previously mentioned, there are 6 known companies in Canada who hold such certification for this type of lifesaving equipment; and knowingly do work on DND RCN, RCAF and Army life rafts and many other types of flotation devices or appliances. Any Canadian company can at any time apply to Transport Canada for one or multiple AMO certifications and therefore DND is not eliminating anyone from bidding!

DND stands by the mandatory requirement of the contractor having to be Transport Canada certified, as holding an* aircraft maintenance organization (AMO) certification. DND is however willing, if the contractor is not certified as AMO for safety equipment as stated in the SOW, please let it be known that DND is willing to accept Transport Canada manufacturing certification for aeronautical lifesaving products, which includes at least one of the following lifesaving products:

Aircraft Life rafts
Inflatable Life preservers
Life preserver Pouches"
