

## "Notice of Proposed Procurement (NPP)"

1. This NPP is issued pursuant to PWGSC Supply Arrangement (SA) # E60PQ-140003/A and covers a requirement from the following Product Category(ies) of the SA:
  - Product Category 1 - Interconnecting Panels and Freestanding Systems;
  - Product Category 2 - Freestanding Height Adjustable Desk/Table Products;
2. Canadian Grain Commission has a requirement for the purchase, delivery and installation of office furniture to Winnipeg, Manitoba, Western Region on or before September 26, 2016 and December 6, 2016.
3. This NPP covers a requirement to be solicited amongst the PSAB stream of Suppliers (SA holders).
4. No trade agreement applies to the requirement.

This procurement is set aside under the federal government's Procurement Strategy for Aboriginal Business. This procurement is set aside from the international trade agreements under the provision each has for set-asides for small and minority businesses. Further to Article 1802 of the Agreement on Internal Trade (AIT), AIT does not apply to this procurement.

5. The bid solicitation is also open to suppliers who are not Supply Arrangement (SA) holders. In order for new suppliers to bid on this solicitation, the new supplier must first qualify for a SA. The process to qualify for a SA is detailed in RFSA # E60PQ-140003/B and can be found on the Government Electronic Tendering Service (GETS - <https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>). Canada is not required to delay the award of a resulting contract pending the evaluation of an arrangement and issuance of a SA by the PWGSC Supply Arrangement Authority.
6. There is no security requirement associated with the requirement.
