5. **QUESTIONS AND ANSWERS – PART1**

Q1. Based on a review of the drawing packages for Edson, St. Paul and Red Deer, the drawing packing for Edmonton appears to be incomplete. Were any drawings omitted or are there additional drawings available for Edmonton to show equipment location, ceiling and lighting configuration, baffle/ light guard locations, etc?

**A1: An error occurred in uploading files to GETS. Please use ‘corrected’ version for tendering. Disregard original file.**

Q2. In each of the Location Specific Appendixes, in section 11 67 23 Shooting Range Equipment, at para 2.4 Gun clearing trap, the tender calls for:

Provide Gun Clearing Trap for a safe and secure means of clearing guns during loading and unloading. Gun clearing traps shall protect both the shooter and bystanders from an accidental discharge by safely containing the bullet.

1. Provide (1) Rifle Rated Gun Clearing Trap; Weapon-Clear as manufactured by MilPolice Equipment, [www.MilPolice.com](http://www.MilPolice.com).
- 2 The clearing trap shall be a self-standing/floor model that does not require a stand or special mounting hardware to secure it. .
3. The clearing trap shall accommodate pistol and rifle rounds up to 0.50 BMG AP and meet Wiltshire Ballistic Services: 48 rounds in total from 300 ft/lbs to 13334 ft/lbs.
4. The clearing trap shall utilize safety signage that illustrates its capabilities and limitations.

A) The domain name [www.milpolice.com](http://www.milpolice.com) has expired, and a search did not identify any company by that name offering the products listed, however there are several other manufacturers with comparable products that will meet or exceed the intended performance of the above mentioned clearing Trap. Will the RCMP consider alternate manufacturers of this product.

**A2.1: The correct domain name is [www.weapon-clear.com](http://www.weapon-clear.com). And has been revised see Addendum No.1 Alternate manufacturers are acceptable provided they meet the performance requirements listed in the specification.**

B) The specification calls for a clearing trap capable of handling up to .50 BMG AP rounds, yet the backstop of the range is specified to handle: “Small arms including handguns, shotguns, and rifles with a maximum velocity of 3600 FPS and maximum energy of 3600 ft. lbs.” Generally this would include rifle calibres in the vicinity of .308 Winchester/7.62x51mm Nato, 30/06 Springfield, but NOT 0.50 BMG. Is this correct or does the RCMP want a clearing trap which is rated to the same ammunition as their back stop?

**A2.2: This is correct the clearing trap is to be rated for a higher caliber than the range.**

Q3. In section 11 67 23 Paragraph 3.2 Installation, in several places there is a reference to target systems, however there does not appear to be any information in any of the specifications or drawing packages identifying requirements for targets. Are there any existing target systems in the range that are being retained/reinstalled? Is there an intent to purchase new target systems as part of this bid? If so, are there any performance requirements for target systems?

**A3: No target systems are included in this tender. Refer to addenda no.1 the target system has been removed from the 3.2 Installation.**

Q4. HEPA filter housings seem to be missing the drawings for the Edmonton facility.

a) Could you please advise if these are available as I need to confirm if they also require the 2 x range exhaust housings each handling 5900 l/s as per the other facilities ?

**A4a: Please see response to question 1 above.**

b) Can I also check that the St.Paul facility also requires these 2 x range exhaust housings as they are shown on the drawings but there is no filter schedule ?

**A4b: Exhaust Fan EF-1 is new and does not require to be filtered. Exhaust Fan EF-2 is new mounted to existing ductwork using existing filters. The HEPA Filter Housing is existing using existing filters.**
