This Amendment is raised to respond to the following questions as submitted to the Contracting Authority:

**Question 1:**

Are there any tipping fees associated with materials to be moved off site to the City Solid Waste facility? If so what are the tipping fees?

**Response:**

Bidders are responsible for contacting their Landfill Facility of choice directly to determine if tipping fees Apply. Although clean fill is normally accepted at no charge, debris and waste is subject to tipping fees. The intent of the project plans and specifications is to reuse as much of the clean fill on-site as possible; Therefore, it is likely that only debris will be hauled off-site. Please refer to Annex B for estimated quantities.
