## **SCOPE OF WORK / DELIVERABLES:**

The scope of work consists of the furnishing of all plant, labour, equipment and material for this wharf reconstruction at fisherman's wharf of Baie-Trinité, QC. The project is to be completed in strict accordance with the specification and accompanying drawings, and subject to all terms and conditions of the Contract.

In general, work under this contract consists of, but will not necessary be limited to, the following:

- 1. Welding Works;
- 2. Underwater Works;
- 3. Installation of temporary facilities required for this project;
- 4. Surface preparation work of the steel surfaces of sheet pile;
- 5. Timber fenders removal;
- 6. Concreting of upper section of 50 m of sheet pile;
- 7. Supply and installation of forms for concrete repairs;
- 8. Disposal of demolition materials;
- 9. General cleaning after work.
