Question 6)

We have had a few teams contacting us to join them on this project but, are not able to commit until the call-up through P3 Canada for Cost Consulting Services is awarded.

An extension to August 17, 2016 has already been provided under Amendment 004.

Question 7)

Appendix C in Addendum 1 of the RFP ask for Fees and Hourly Rates from a Costing Specialist in both tables.

However, according to the Refined Cost Estimate description in the RS-1 Phase 1 - Pre-Procurement phase (on page 34):

The AA Team will be required to review the design parameters and the initial functional space program and provide design and specification information to permit the development of a refined cost estimate (including capital, operational and lifecycle components) for the Facility by a Professional Quantity Surveyor to be appointed by LAC.

Is the proponent required to retain their own Cost Consultant?

Answer 7)

Proponents are not required to retain a Cost Consultant as part of their team. LAC has retained an independent Cost Consultant to provide cost estimates at specific deliverable milestones.

In Appendix C, for tables that relates to Optional Services and Future Contract Amendments after award, the Costing Specialist hourly rates would apply only if warranted.
