Title: Fresh prepared box lunches

This amendment is to modify line item 7 of Annex "C" Minimum Mandatory Criteria and Point-rated Criteria on page 20 of 27 of the solicitation document.

DELETE: The In-Transit Meals - "Box Lunches" must be securely closed with packing tape and must be delivered in disposable cardboard boxes ONLY (25cm long, 18 cm wide, 9 cm high).

INSERT: The In-Transit Meals - "Box Lunches" must be securely closed with packing tape and must be delivered in disposable cardboard boxes ONLY (25cm long, 18 cm wide, 9 cm high). In the event that the Offeror cannot provide a sample lunch box of the required measurements, boxes of other sizes will be allowed for evaluation purposes only. The Offeror is requested to provide documentary proof of their ability to supply boxes of the required size if awarded the Standing Offer. Documentary proof must consist of a quote, catalogue or written/email correspondence from the intended supplier. If documentary proof is not provided with the Offer, it may be requested by the Standing Offer Authority after bid close.
