2.6 Mandatory Site Visit

It is mandatory that the Bidder or a representative of the Bidder visit the work site. Arrangements have been made for the site visit to be held at CFB Esquimalt with everyone meeting at the Dockyard main gate which is located at the end of the road travelling West on Esquimalt Road, Victoria BC, on 11 August 2016 at 0800 hrs. Any further transportation will be arranged by DND.

Bidders must communicate with the Contracting Authority no later than 1500 hrs on 10 August 2016 to confirm attendance and provide the name(s) of the person(s) who will attend. All personnel in attendance are required to bring government issued photo ID. Bidders will be required to sign an attendance sheet. Bidders should confirm in their bid that they have attended the site visit. Bidders who do not attend the mandatory site visit or do not send a representative will not be given an alternative appointment and their bid will be declared non-responsive. Any clarifications or changes to the bid solicitation resulting from the site visit will be included as an amendment to the bid solicitation.
