This amendment is being raised to 1) advise Proponents of an upcoming Optional Site Visit and 2) provide responses to Requests for Clarification.

OPTIONAL SITE VISIT

Arrangements have been made for a tour of the work site. The site visit will be held on Wednesday, August 17, 2016 at 09:00 a.m. at Lock #45, 175 Port Severn Rd. N., District of Muskoka, Port Severn, Ontario, L0K 1S0.

Proponents should dress according to outdoor weather conditions and wear safety boots or hiking shoes as well as a reflective vest as a minimum personal safety apparel.

Proponents are requested to communicate with the Contracting Authority named on the RFP - Page 1 two (2) business days before the scheduled visit to confirm attendance and provide the name(s) of the person(s) who will attend. Proponents may be requested to sign an attendance form.

Proponents who do not attend or send a representative will not be given an alternative appointment. Proponents who do not attend will not be precluded from submitting a proposal. Any clarifications or changes to the solicitation resulting from the site visit will be included as an amendment to the solicitation.

REQUESTS FOR CLARIFICATION

- Q1. As there is no noted mandatory site visit for the above noted project, would PWGSC consider posting the list of document takers so subconsultants can connect directly with interested proponents? We usually attend the mandatory visit as an opportunity to connect directly with interested proponents. We will certainly self-identify as an interested sub-consultant, but it is always nice to connect directly with the bidders.
- A1. Public Works and Government Services Canada (PWGSC) procurements are tendered through buyandsell.gc.ca, the official distributor for the Government Electronic Tendering Service (GETS). Buyandsell offers those interested in a tender to add their name to a List of Interested Suppliers. Please visit the tender page to determine availability of a Supplier's List.
- Please also note that an Optional Site Visit has been scheduled for Wednesday, August 17, 2016.
- Q2. In reviewing the attached RFP document we did not come across a pre-bid site meeting. Is PWGSC intending on having one (mandatory or non-mandatory?).
- A2. An Optional Site Visit has been scheduled for Wednesday, August 17, 2016.
- Q3. We would like to have clarification concerning the language requirements for this proposal. Is it possible to submit it in French?
- A3. Yes, proposals may be submitted in either official language of Canada.
- The language of communication for the project (construction and project documents, reports, meetings, correspondences, etc.) is English.
