This amendment is being raised to respond to questions submitted in response to solicitation 5P420-16-5141/A:

### **QUESTIONS AND ANSWERS:**

- Q1. Is there an approved method or procedure for ensuring the required "weed free" topsoil? (i.e. can it be screened and visibly free of weeds or is it the Contractor's responsibility to pay for a baking process or special testing for the soil prior to installation?
- A1. Contractor must provide certificate that topsoil is weed free.
- Q2. Will alternatives to the ECO BOND LBP product be considered if they are determined to be comparable products?
- A2. Alternatives will be considered as long as the ECO BOND LDP specifications are met.
- Q3. Does the granular fill and top soil need to be sourced outside the pit or is there a source within JNP that may be used?
- A3. Granular fill and top soil are both to be sourced outside of Jasper National Park.
- Q4. Does the entire work zone need to be fenced in for the construction project?
- A4. Section 1.8.7 (General Conditions) The Contractor will ensure work site excavations are secure behind protective fencing when contractor is not on site.
- Q5. Under Terms of Reference Scope of work Item 2c and 2d seem to contradict each other. Is there asbestos tile to remove for the house?
- A5. Asbestos tiles were already removed from the house.
- Q6. Have all the utilities been disconnected form the structures?
- A6. Electrical: disconnected, lines removed Gas: disconnected, meter removed Telus: will need to be disconnected

Sewer: connected, remove during demolition

Water: connected, service to disconnected during demolition

- Q7. How many tress are to be removed?
- A7. The number of trees to be removed is at the discretion of the Contractor, in order to access the work area. A permit from PCA is required before removing trees.
- Q8. Can we leave the wood from the trees on site?
- A8. No wood from removal can be left on site. Wood needs to be bucked and limbed in 10 to 12 foot lengths, and transported to Marmot Pit.

All other terms and conditions remain unchanged.
