This amendment has been issued to answer a question from a bidder.

Q13. I cannot seem to find lighting spec for Type S and T fixtures and car plug pedestals.

A13. Car plug in pedestals, luminaires and poles for type T and type S are not part of the contract. The designed concrete bases for the car plug pedestals and for the luminaire poles have generic bolt patterns (and bolt sizes) that should allow most manufacturers to supply equipment in the next phase of the project.
