This solicitation amendment 001 is issued to answer questions raised from the industry.

Q1 On page 15 of the RFP, Mandatory Technical Criterion MT1 requires “The Proposal must demonstrate that within the past ten (10) years (as of closing date of RFP), the Proponent has completed at least one project demonstrating they have experience delivering development plans for services of a scope and nature similar to those required under this RFP for a site that is a minimum of 15 hectares.” Does a project the Contracting Authority require that the representative project be fully implemented and completed or would a plan to redevelop (the Lebreton Redevelopment Plan) suffice as it was not implemented and another plan was awarded the contract?

*R1 The project does not have to be fully implemented but, it is the responsibility of the bidder to ensure that the example project provided for the mandatory criteria properly and completely represents the experience of the bidder in “delivering **development plans** for services of a scope and nature similar to those required under this RFP for a site that is a minimum of 15 hectares.”*

Q2 Does this contract preclude the winning firm from bidding on subsequent work after this contract, ie: engineering work on components of the buildings within the Master Plan?

*R2 It is not the intent of this contract to prevent the winning bidder from bidding on or being involved with subsequent work related to the redevelopment.*
