QUESTION 31:

T&C

p. 3/36 - section 2.5

As per section 2.5 p 3/36 of the RFP document, both official languages can be used for CDRL and be translated once approved by TA. Industry assumes translation will be the responsibility of PWGSC/DND. Can you please confirm it is the case? If so, can you please confirm time for translation has been considered in the project schedule?

ANSWER:

The winning Bidder, (i.e the Contractor) will be responsible, as identified in specific places within the SOWs, CDRLs and DIDs to produce and deliver bilingual (English and French) documents.

Where it is specified that the information must be delivered in both languages, time for translation has been considered in the project schedule (see CDRL 213 as an example).

Translation will be the responsibility of DND for those documents that were not identified to be delivered in both languages (English and French).

QUESTION 39:

Annex C,
App CA,

In annex C, appendix CA, p.7 of 36, it is written the bidder must specify its Acquisition Bid Price, defined as the summation of ISS-CLIN-1 through ISS-CLIN-6 inclusive found in Annex H [...]. Should we read 'Specify its Acquisition Bid Price, defined as the summation of ISS-CLIN-1 through ISS-CLIN-6 inclusive found in Annex E' as Annex H is for Canada use only ? Can you please change the appendix CA accordingly?

ANSWER:

For the purposes of the ITB evaluation found at Annex C, the acquisition bid price is the summation of CLIN-1 through CLIN21 inclusive as identified in Annex B. Annex C - Appendix CA will be updated accordingly.

For the purposes of the ITB evaluation found at Annex C, the in-service support bid price is the summation of CLIN-1 through CLIN-6 inclusive, as identified in Annex E. Annex C - Appendix CA will be updated accordingly.

QUESTION 91:

Provision of GFE

We understand that CAF Equipment Integration and Compatibility will be tested and assessed during the UITPT phase however as an example under JCG-SRS 1269 it appears you are asking us to input a self-assessment score against this requirement along with references and comments. To date the only evaluation we have been able to do is compatibility trials at the Industry Day. So if no testing is to be carried out by the contractor at this stage are you asking us to enter a self-assessment score based upon the limited trials/ evaluation carried out at the industry day and then apply our engineering/ human factors and mask design expertise to enter a score we believe we would then achieve during the UITPT phase?

ANSWER:

Correct as there is no intention to provide GFE over and above that offered in Section 2.4.1 of Annex A.

QUESTION 128:

We are up to amendment 7 and are wondering if the Canadian government is considering reissuing the base document with all the amendments updated and included?

ANSWER:

Because of the high volume of questions and updates to the RFP, it is the bidder's responsibility to track the changes and updates.

In order to avoid errors Canada will not re-issue a revised copy of the RFP.

QUESTION 129:

Warning to bidders that Canada is considering offering Bidders the opportunity to train UAPE participants.

ANSWER:

Canada is considering offering Bidders the opportunity to train Bid Evaluation participants in the use of their proposed Joint CBRN GSR directly before it is assessed during the User Acceptance Performance Evaluation (UAPE) (Serial 7 of Annex F – Bid Evaluation Plan).

Bidders should plan to have their trainers available to train participants at a location in Ontario, Canada for 4 consecutive weeks. The training will be delivered for one day in each of the 4 weeks to an audience of up to 15 personnel (participants and Bid Evaluation Staff). Canada will provide the Bidder's delivered Joint CBRN GSR for the 15 personnel to be trained and provide to the Bidders their training package delivered to Canada under Phase 2C. Bidders will only be required to bring their training tools/accessories, if needed to conduct their training session.
