Q2) On the DAS Permit is PWGSC paying for the disposal fees or should the contractor make allowance for it?

A2) The disposal at sea permit fee will be paid by The Owner.

Q3) Will the vessels be removed from the areas to be dredged, including the slips adjacent to the dredging?

A3) Vessels will be removed from the dredge area by the Harbour Authority as required.

Q4) There is a floating boat house at dock 409 in an area indicated to be dredged. Will it be removed by others prior to dredging that area?

A4) No dredging under the boat house at dock 409 will be required.
