2. Questions Part 1

- Q.1 To comply with the reporting date, we checked with DICOM offices for delivery to Ottawa and pick up must be made no later than Thursday, August 25th. You understand that we are in remote areas, and contractors have until Thursday, August 25, 2016 at 14 h 00 to submit bids to BSDQ. We need to analyze and compile everything. Is it possible to file our envelope your Sept-Îles facilities (637 De Quen Avenue)?
- A1. No, this is not possible. Our bid receiving office has strict precedures to ensure all bids are received in a fair manner. We do not have such an office in Sept Iles.
- Q2. To quote the spec 09 67 00.05 page 5 Item No. 2.3..2 are given, do not correspond with the table A605 finished, what information we need?
- A2. In the table of A605 finishes, change the types of finishes of walls of premises 504, 506, 508, 510, 512, 513 for M5. See addendum A01.
- Q3. We are missing "Division 03" 03 20 00 Concrete Reinforcing that is indicated in the table of contents.

- A3. The section is included in the architectual A01 section of Addendum No.1
- Q4. I wonder if the spacing frame in the soles is 150mm or 300mm, see S006 plan. Because it tells us the number, but I do not know if it's only in one direction or is the total reinforcement in the sole.
- A4. See Addendum No.1 section S01.
- Q5. Drawing A605 requestes sprayed paint (P2), I understand that is applied to the steel bridging, the ceiling steel structure will be painted? Will be painted by the structure supplier? If done on site by architecture will it be primed at the factory by the manufacturer?
- A5. The structure will be ready in the factory by the manufacturer and will be painted on site.
