

Question #1: The CODAN products listed below were discontinued by CODAN before the products were transferred to Canada.


Based on the above there are two options:

- 1. Acquire used assets of the products that are listed under Codan
- 2. Request an equivalent part number that would also necessitate a new modem to be acquired as well.

Response #1: SSC needs to retain the CODAN stuff as we have a significant deployment of this product and swapping these out means a whole host of changes that are not feasible in our global deployment. We would accept refurbished CODAN equipment or an acceptable approved alternative.

SSC have also identified other products within the Annex A that are no longer available from the OEM and as such will be subject to the same level of discretion stated above for the bid response.

Question #2: Concerning Item 29 of the Pricing Sheet, we request specifications of this item which was originally labeled as "Compression Connector, Ultra Range, RG11". The response to question #4 in amendment 002 and the specification write-up in Annex A rev 1 column G for item 29 provides specifications for a 16W Terrasat BUC. Please clarify the requirement and provide specifications.



1. If the Bidder offers a substitute product, Canada reserves the right to request a sample from the Bidder in order to determine its equivalency in form, fit, function, quality and performance to the item specified in the bid solicitation.

The Bidder must, upon request from the Contracting Authority, provide a sample to the Technical Authority, transportation charges prepaid, and without charge to Canada, within 5 calendar days from the date of request. The sample submitted by the Bidder will remain the property of Canada' will be considered as part of the deliverables in any resulting contract. If the sample does not meet the requirements of the bid solicitation or the Bidder fails to comply with the request of the Contracting Authority, the bid will be declared non-responsive.

2. The Technical Authority reserves the discretion to determine if a product requires to be tested in order to ascertain its equivalency in form, fit, function, quality and performance to the item specified in the bid solicitation.
