Questions and Answers

You will find below answers to questions that were asked by a potential bidder. You must take in consideration this information when submitting your proposal.

Question 1

In Part 3, Section 1.2 b, page 11 (Variation in Professional Services Resources Rates): Does it apply between sub-categories? For example, the difference must not be more than 10% between senior and intermediate engineers.

Answer 1

The senior engineers and the intermediate engineers are two different categories. There is 6 categories. The categories are:

- Project Manager
- Senior Engineer
- Intermediate Engineer
- Senior Technician
- Intermediate Technician
- Junior Technician

Question 2

Part 3, Section 1.2, pages 11-12 and Attachment 4 pages 74-76: There is no provision for sub-contract. Does it mean that it won't be allowed under the resulting contract? If yes, it contradicts the following points.

Part 3, Section 1.1 b) (iv) (A): page 11: it is stated that "the proposed resources may be employees of the Bidder or employees of a subcontractor"

Part 4, Section 1.1.1 states that "the experience of the Bidders' affiliates (...), subcontractors, or suppliers will not be considered".

Answer 2

There is no contradiction

Part 3, Section 1.1 b) (iv) (A): page 11:

The proposed resources can be employees of your company or employees of a subcontractor. For example, in point 3 "Qualification of Technical Resources" of Attachment 2 you could proposed your employees and/or employees of a subcontractor

Part 4, Section 1.1.1

This relate to the experience of the Bidder. The experience of the bidder means the experience of your company. For example, in point 4 "Qualifications of the Bidder" of Attachment 2, we will only consider the experience of your company. The experience of your affiliates and/or subcontractors will not be considered
