- .2 Clarification: Reuse existing doors and frames from existing building inventory.

3. Reference Specification Section 08 71 00: Door Hardware

- .1 Delete section in its entirety.
- .2 Clarification: Reuse existing door hardware from existing building inventory.

2. DRAWINGS

1. Reference Drawing A1 of 4 – Main Floor Plan Demolition & Renovation

- .1 Reference Detail 1/A1/A1:
 - .1 Delete note: Millwork to be removed. Millwork has already been removed from site.

2. Reference Drawing E1 of 2 – Main Floor Plan Electrical Demolition and Renovation, Lighting, Power, and Communications.

- .1 Reference Detail 4/E1/E1:
 - .1 Relocated switches on glass wall to adjacent GWB wall beyond extent of door swing.

3. CLARIFICATIONS

- 1. In the current boardroom, all video equipment will be removed prior to the start of construction. The removal is not part of this contract.
- 2. Carpet is to be removed and stored for re-use within the limit of contract.
- 3. All re-used and new light fixtures are identified as shown on the plans.
- 4. When removing the existing exterior double door to install new exterior glazing, any pavers that are disturbed are to be re-instated to match existing.
- 5. Wall cabinet in existing boardroom is to be included in the demolition.

6. Construction can take place during regular work hours (7am to 5pm) Monday to Sunday. Any intrusive/disruptive work that will affect other building tenants will be completed after hours. Any life safety system work will be completed after hours.
7. Any material that is part of the existing demountable wall system is to be stored on the first floor and the contractor is responsible to sort the product pieces in to its proper location within the storage area.
8. Depth of radiant piping unknown. Reference general note 9, E1 of 2:

“COORDINATE DRILLING INTO EXISTING CONCRETE CEILING WITH GENERAL CONTRACTOR TO ENSURE EXISTING RADIANT HEATING SYSTEMS ARE NOT DAMAGED.”
9. Contractor is to carry the cost for Commissionaire.
