1. Question 3: Is a Section 28 letter from the Alberta Workers' Compensation Board stating that we have out of province coverage sufficient as a replacement for the letters from the BC and Yukon Workers Compensation Boards?

Answer 3: As an interim measure, yes, this will suffice; however if your company becomes a successful candidate then you will need to apply for the letter of good standing for British Columbia and Yukon Territory once a contract is awarded. The letter of good standing for British Columbia and Yukon Territory will need to be provided prior to any work commencing.

Clarification in Part 5 – Certification and Additional Information, Item 5.2.5 Workers' Compensation Certification – Letter of Good Standing:

If a bidder is not operating in British Columbia or the Yukon Territory area, as an interim measure, a letter of good standing from the province/state in which the company resides will be acceptable until such time when a bidder becomes a successful candidate and a contract is awarded. The letter of good standing for British Columbia and Yukon Territory will need to be provided prior to any work commencing.
