This amendment has been issued to answer questions from bidders and revise the tender package.

This tender now closes on September 8, 2016 at 2:00 PM MDT.

A. Questions

- **Q1**. Please confirm that all millings will be hauled and stockpiled in the 8Mile Pit.
- A1. Refer to Section 02 41 31 14, Clause 1.1.4.
- **Q2**. Can grubbed material be chipped or burned in the 8 mile pit and left onsite? Hauling of this material outside of the park will add considerable cost.
- **A2**. Refer to Section 31 11 00, Clause 3.4.1.
- **Q3**. Please confirm if all waste material from the ditch excavation can be stockpiled and left in the 8 mile pit?
- **A3**. Refer to Section 31 24 13, Clause 1.2.2.1.
- Q4. Please confirm that material stripped in the 8 mile pit does not require screening?
- A4. Refer to Section 31 24 13, Clause 1.2.1.1.
- **Q5**. Will the stripped material from the ditch cleanout require any screening? This will add considerable cost.
- **A5**. Refer to Section 31 24 13, Clause 1.2.2.1.
- **Q6**. Will work be permitted on Sundays and on the Thanksgiving Long weekend due to the Oct 21 deadline?
- A6. Refer to Section 01 14 00, Clause 1.4.
- Q7. How will the moving and restock piling of the existing overburden in the 8 Mile pit be paid?
- A7. Refer to Section 31 11 00, Clause 1.2.
- **Q8**. Please confirm that use of the 16mm material in the 8 Mile pit can be used for shouldering at no charge.
- **A8**. Refer to Section 01 11 00, Clause 1.9.1.
- Q9. Where is stripping in the 8 Mile pit to be stockpiled?
- **A9**. Refer to Section 31 24 13, Clause 1.2.1.
- **Q10**. The stripping quantity in item 3a seems high for the amount of area that is being grubbed. Is this quantity accurate?
- A10. This is correct.
- **Q11**. Is the large quantity of 16mm aggregate in item 4a for stockpile inventory after construction? **A11**. Yes.
- Q12. What will the liquidated damages be if the project exceeds the Oct 21 2016 deadline?
- A12. Refer to Section 01 25 20, Clause 1.2.
- **Q13**. Would Parks Canada be willing to change the unit of measure for the aggregate production from cubic metre to tonne? (Crushing sub-contractor question).
- A13. Refer to Section 31 05 16, Clause 1.2.1.

- **Q14**. Work Restrictions 1.3.3 Would Parks Canada reconsider allowing camping in the pits for the crews?
- **A14**. Refer to Section 01 14 00, Clause 1.3.3.
- Q15. Summary of Work 1.3 Work Covered by Contract Documents (0.4.9.4) states "water can be obtained from Parks Canada compound or from digging a hole in pit below the water table." However, in Work Restrictions 1.3.4 it states "no water is available in Ranger Pit either directly or through exposing the submerged water table." Which one applies?
- **A15**. Refer to Section 01 14 00, Clause 1.3.4 as this is correct.
- **Q16**. Will Parks Canada allow night time crushing (24 hour shifts) or night time paving?
- A16. Refer to Section 01 14 00, Clause 1.4.
- **Q17**. Summary of Work 0.4.4 states that slot milling is required but there isn't an item in the unit price schedule. Is this considered incidental?
- A17. Refer to Addendum #1.
- **Q18.** Work Restrictions 1.3.8 states that "no portion of the existing material in the Pit will be rejected or wasted. All material must be utilized in the product being produced. "Can the reject material be used for another portion of the work in this contract?
- **A18**. Reject material cannot be used for this project. The intent here is that the Contractor demonstrates that all responsible and necessary steps have been undertaken before a material is classified as reject.
- **Q19.** One of the issues we are seeing is that the crushing contractors feel that the deadline to complete the aggregate production to allow for the paving to meet the completion date is too unfeasible. Could there be alternatives without reducing quantities? For example, do you expect all of the material to be in stockpile prior to paving? Or can the crusher move out and then move back in to finish the quantities? Even possibly allowing for reject material could improve production of the aggregate. Also, allowing for 24 hour shifts could assist with this issue.
- A19. Crushing equipment could leave the pit and come back. However, this is the Contractor's responsibility as per Section 01 11 00, Clause 1.7.
- **Q20.** Is the contractor allowed to utilize the 16mm aggregate that is being crushed for this contract for the production of asphalt?
- A20. Yes.
