This solicitation amendment 004 is issued to answer questions raised from the industry.

Q1 For the Point Rated Criteria, RT1 can you please confirm if the “maximum two projects undertaken within the last 15 years” need to be included in the curriculum vitae referenced in sub section e) – ie. within their 3 page limit.

R1 Yes. The two example projects should be included as part of the CV for each proposed person within this criterion.

Q2 Can you confirm if the RT1, subsection e) curriculum vitae also needs to include the information listed in subsections f) and j)?

R2 Yes. The CV requested in subsection e) should include the information requested in subsections f) and j)

Q3 In RT1, subsection e), it states that “for each discipline, submit a maximum of two curriculum vitae of senior personnel”. Can you clarify if each of the two CV's are weighted within the discipline equally? Is one resume to be the primary contact with the second resume acting as the back-up?

R3 Each of the CV's submitted as part of this criterion will be weighted and evaluated equally. Correct, one resume is to be the primary contact with the second being the back-up.
