PART 1 - GENERAL INFORMATION

1.1 Statement of Work

The Work to be performed is detailed under Article 6.2 of the resulting contract clauses.

1.2 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

1.3 Trade Agreements

The requirement is subject to the provisions of the North American Free Trade Agreement (NAFTA), and the Agreement on Internal Trade (AIT).

PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the *Standard Acquisition Clauses and Conditions Manual* (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The 2003 (2016-04-04) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

2.2 Submission of Bids

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

2.3 Former Public Servant

Contracts awarded to former public servants (FPS) in receipt of a pension or of a lump sum payment must bear the closest public scrutiny, and reflect fairness in the spending of public funds. In order to comply with Treasury Board policies and directives on contracts awarded to FPSs, bidders must provide the information required below before contract award. If the answer to the questions and, as applicable the information required have not been received by the time the evaluation of bids is completed, Canada will inform the Bidder of a time frame within which to provide the information. Failure to comply with Canada's request and meet the requirement within the prescribed time frame will render the bid non-responsive.

Definitions

For the purposes of this clause,

"former public servant" is any former member of a department as defined in the [Financial Administration Act](#), R.S., 1985, c. F-11, a former member of the Canadian Armed Forces or a former member of the Royal Canadian Mounted Police. A former public servant may be:

- a. an individual;
- b. an individual who has incorporated;
- c. a partnership made of former public servants; or
- d. a sole proprietorship or entity where the affected individual has a controlling or major interest in the entity.

"lump sum payment period" means the period measured in weeks of salary, for which payment has been made to facilitate the transition to retirement or to other employment as a result of the implementation of various programs to reduce the size of the Public Service. The lump sum payment period does not include the period of severance pay, which is measured in a like manner.

"pension" means a pension or annual allowance paid under the [Public Service Superannuation Act](#) (PSSA), R.S., 1985, c. P-36, and any increases paid pursuant to the [Supplementary Retirement Benefits Act](#), R.S., 1985, c. S-24 as it affects the PSSA. It does not include pensions payable pursuant to the [Canadian Forces Superannuation Act](#), R.S., 1985, c. C-17, the [Defence Services Pension Continuation Act](#), 1970, c. D-3, the [Royal Canadian Mounted Police Pension Continuation Act](#), 1970, c. R-10, and the [Royal Canadian Mounted Police Superannuation Act](#), R.S., 1985, c. R-11, the [Members of Parliament Retiring Allowances Act](#), R.S., 1985, c. M-5, and that portion of pension payable to the [Canada Pension Plan Act](#), R.S., 1985, c. C-8.

Former Public Servant in Receipt of a Pension

2.4 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than ten (10) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

2.5 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Saskatchewan.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the bidders.

PART 3 - BID PREPARATION INSTRUCTIONS

3.1 Bid Preparation Instructions

Canada requests that bidders provide their bid in separately bound sections as follows:

Section I: Technical Offer (1 hard copy)

Section II: Financial Offer (1 hard copy)

Section III: Certifications (1 hard copy)

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that bidders follow the format instructions described below in the preparation of their bid:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to the bid solicitation.

In April 2006, Canada issued a policy directing federal departments and agencies to take the necessary steps to incorporate environmental considerations into the procurement process [Policy on Green Procurement](http://www.tpsgc-pwgsc.gc.ca/ecologisation-greening/achats-procurement/politique-policy-eng.html) (<http://www.tpsgc-pwgsc.gc.ca/ecologisation-greening/achats-procurement/politique-policy-eng.html>). To assist Canada in reaching its objectives, bidders should:

- 1) use 8.5 x 11 inch (216 mm x 279 mm) paper containing fibre certified as originating from a sustainably-managed forest and containing minimum 30% recycled content; and
- 2) use an environmentally-preferable format including black and white printing instead of colour printing, printing double sided/duplex, using staples or clips instead of cerlox, duotangs or binders.

Section I: Technical Bid

In their technical bid, bidders should explain and demonstrate how they propose to meet the requirements and how they will carry out the Work.

Section II: Financial Bid

Bidders must submit their financial bid in accordance with the Basis of Payment. The total amount of Applicable Taxes must be shown separately.

PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION**4.1 Evaluation Procedures**

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

4.1.1 Technical Evaluation

Mandatory and point rated technical evaluation criteria are included in Annex “C”

4.1.2 Financial Evaluation

The Total Bid Price will be calculated in the following method:

The unit price quoted for each item will be multiplied by the estimated quantity to arrive at a total price per item. The total prices per item will be aggregated to determine the Total Assessed Bid Price.

4.2 Basis of Selection - Lowest Price Per Point

- 1. To be declared responsive, a bid must:
 - a. comply with all the requirements of the bid solicitation;
 - b. meet all mandatory technical evaluation criteria; and

- c. obtain the required minimum of 60% percent overall of the points for the technical evaluation criteria which are subject to point rating. The rating is performed on a scale of 125 points.
2. Bids not meeting (a) or (b) or (c) will be declared non-responsive. Neither the responsive bid that receives the highest number of points nor the one that proposed the lowest price will necessarily be accepted. The responsive bid with the lowest evaluated price per point will be recommended for award of a contract.

PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Unless specified otherwise, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

5.1 Certifications Required with the Bid

Bidders must submit the following duly completed certifications as part of their bid.

6.12 Insurance – Specific Requirements

The Contractor must comply with the insurance requirements specified in Annex “C”. The Contractor must maintain the required insurance coverage for the duration of the Contract. Compliance with the insurance requirements does not release the Contractor from or reduce its liability under the Contract.

The Contractor is responsible for deciding if additional insurance coverage is necessary to fulfill its obligation under the Contract and to ensure compliance with any applicable law. Any additional insurance coverage is at the Contractor's expense, and for its own benefit and protection.

1. Purpose

Public Works and Government Services Canada (Client) on behalf of Agriculture and Agri-Food Canada (AAFC) requires full narrative appraisal reports to provide the value estimates necessary to facilitate the divestiture of AAFC's interest to the Province of Saskatchewan for the control and ownership of several dams/water retention structures and associated lands and easements (subject properties) located in the Province of Saskatchewan. The appraisal reports are to establish a Market Value of the Fee Simple Interest of the subject(s) assuming 3 Scenarios that are further described in the Statement of Work (SoW). There is the potential for the divestiture of up to 26 dams/water retention structures/canals to occur over roughly 3 to 6 years.

2. General Description of Subject Properties

The following list of subject properties are proposed for divestiture:

Highfield Dam
Lafleche Dam
Moosomin Dam
Cypress Lake, comprised of Cypress Lake East and West Dams as well as inlet and outlet canals (inlet and outlet canals included in area labelled Reservoir (coloured light blue) on the landownership map.
Eastend Dam
Val Marie Dam
West Val Marie Dam

The above list reflects dams/water retention structures and associated lands and easements (subject properties) located in the Province of Saskatchewan. The property locations are included with the SoW. Following is general background information with respect to these properties.

The subject water storage infrastructures consist of reservoirs and diversion works of various sizes located throughout southern Saskatchewan. Each reservoir and diversion is configured somewhat differently; however they all have some or most of the following components:

- Reservoirs:
 - Main earthen embankment and other related dykes;
 - Concrete or earthen overflow spillways;
 - Earthen emergency spillways;
 - Approach channels and discharge channels;
 - Inlet and Outlet structures, riparian outlet, irrigation outlet or both;
- Diversion works:
 - Main earthen embankment or concrete dam in the stream channel;
 - Overflow spillway or weir, to evacuate excess flows downstream;
 - Gated control structure near the weir, to regulate flows into the diversion canal;
 - Diversion canal to carry water out to the off-stream reservoir; and
 - Canal outlet structure at the reservoir.
- The water storage projects and dams were built between 1939 and 1960.
- Most subject properties are located in the south-western region of Saskatchewan, within a radius of about 300 km around the town of Swift Current. One of the subject properties is located within a radius of about 300 km from Regina.
- The general purpose/use of the dams/water retention structures may include Irrigation, Recreation, Urban Water Supply, Rural, Domestic, Stock Watering, and minor Flood Attenuation. Note some subject properties may have a water drawdown limit to protect the aquatic life in the reservoir, and or wildlife, and or other.
- The dams/water retention structures (subject properties) may include miscellaneous building improvements associated with the operation of the structures. Examples include small building(s) used as control centers for operation / remote operation of the spillway gates, large generator(s), heating system(s), computer(s), control system(s), communications equipment(s), etc.

3. Background Information Available

Public Works and Government Services Canada (PWGSC) expects to be able to provide the appraiser with the following additional information upon award of the contract. Please note a number of the listed items are included with the SoW.

- Date of Construction.
- Land use area/acres (note: some of the subject properties may include land area that is under review by Department of Justice (DoJ)).
- Land Area at Full Supply Level (FSL), is the water level at the same elevation as the crest of the spillway.
- Land Area at Top of Dam contour.
- Spreadsheets and maps that summarize the parcels that are involved. Canada Lands at each project to be valued (see attached images and spreadsheets).

***Canada Lands** to be valued for each project/subject property are included in the landownership spreadsheets and as a visual aid only are labelled Reservoir (**coloured light blue**) on the maps. The subject property/Reservoir lands (coloured light blue) include lands submerged and lands that are not submerged.

Please note: The maps provided are for visual aid only (please see disclaimer on maps) and should be used together with the landownership spreadsheets. The information contained in the landownership spreadsheets is considered to be the landownership record verified by Department of Justice Canada.

- If applicable, lease or license or memorandum of understanding agreements for uses within the "take line" owned by AAFC.
- Current construction costs.
- Cost of remediation/decommissioning provided by AAFC.
- Operating Costs and annual Capital Investment Cost estimates and risk costs (liabilities) based on information provided by AAFC.
- Remaining economic life (AAFC estimates).
- If applicable, existing agreements such as agreement(s) for roadway over top of dam.
- Information for inspection will be provided upon award of the contract.

Please note, AAFC cost estimates are provided for the analysis; however the appraiser is required to confirm/cross check the figures. Also, the appraiser is required to cross check information provided by AAFC and PWGSC.

PWGSC and AAFC will attempt to provide relevant material if available; however the appraiser should be prepared to complete research/use historic resources as required to fill in information gaps. As an example, the appraiser may need to research the natural course of the creek/water course.

4. Deliverables

- There are three subject properties that require appraisals. Each subject property requires an individual standalone full narrative appraisal report.
- The appraiser may value the subject land by parcel, quarter section, half section, Section, or by block. The specifics of each parcel, the subject market, and the highest and best use of the land will likely determine which approach is most appropriate. If the land is relatively homogeneous then a value per acre applied to a homogeneous block is appropriate. If the lands have different value attributes then separate values should be established.
- Canada's lands are held in fee simple. The appraiser is to value the subject lands as fee simple.
- The effective date for the valuation is prospective at April 1, 2017.
- Subject to the contracts being in place, the expectation is that the subject properties will be inspected in the fall of 2016 with delivery of the draft reports due the first week of February 2017 and delivery of final reports due the first week of March 2017. Inspection and delivery dates to be confirmed.
- **Scenarios** - Two types of value estimates (which include **3 value scenarios**) are required to comply with Treasury Board Policy. Following is a description of the scenarios.

Scenario 1. Value in Use and Scenario 2. Value in Exchange

The first value estimate is to value the subject properties based on their Highest and Best Use to establish the opportunity cost of the disposal. In this regard both the Value in Use and Value in Exchange must be established. (Value in Use represents the capital investment to be transferred and Value in Exchange represents the value if the properties were sold on the open market without the requirement for continued operation).

The Value in Use would reflect the value of the land acquired for the creation of the dam/water retention structure and depreciated capital infrastructure investments. The depreciated value of the water control structures will be determined in accordance with industry standards.

It is anticipated that without an operational subsidy that the subject would not be marketable. As such if the Highest and Best Use determines that there would be no demand for the existing facility the value of the property assuming that the subject/reservoir has been decommissioned and remediated is required.

Please note the analysis requires the use of a hypothetical condition/extraordinary assumption, further discussed below, related to the existence of the reservoir.

The land acquired for the creation of the reservoir (subject) should be valued to reflect a Highest and Best Use of the land prior to the creation of the reservoir (subject) and with no account taken for any anticipated or actual use resulting from the creation of the reservoir (subject).

Assuming the hypothetical removal of the dam/water retention structure/reservoir and remediation, the analysis/land values should reflect a Highest and Best Use without the existence of the reservoir.

An extraordinary assumption that the estimated value is based on the subject/reservoir being decommissioned and remediated and that the estimated cost of remediation/decommissioning is excluded from the estimated value as it is beyond the scope of this appraisal is required.

Additional Context Scenarios 1 and 2

Scenario 1 is intended to capture the opportunity cost to create the dam/water retention structure/reservoir if it was not in existence. The Extraordinary Assumption would be that any surrounding recreational development would not be in place.

Scenario 2 is the "break-up" value if the dam/water retention structure/reservoir did not have to continue. Therefore, what is the value of subject on the open market given the potential revenues, expenses and liabilities that the private sector purchaser would incur. It is anticipated that the dam/water retention structure/reservoir is an operational liability and that in order to sell the subject the lands would have to be returned to their original state and sold. This reflects a worst case scenario and is likely hypothetical.

Scenario 3. Value in Exchange with Restrictions

The second value estimate is to consider the market value in exchange given the restrictions that will be imposed on the transfer to the Province. The legal restrictions for the dam/water retention structure/reservoir and associated lands are to ensure continued public use together with the assumption of all future liabilities arising from the ownership and operation of these assets.

Additional Context Scenario 3

Under Scenario 3 the land use restrictions of development within a flood zone need to be addressed. There may be some value to lands that are not subject to

development restrictions if they are above the take line, of which there may be minor parcels under Scenario 3, however they would likely be of minor set-off value.

Value in exchange based on continued public use. In addition to the subject properties under Scenario 3, examples would include transfers of bridges, airports, etc., that must continue to operate. Frequently requiring an operational subsidy with the transfer. Therefore, it is probable that the value of the subject may be nominal to reflect transfer of ownership, with other good and valuable consideration.

Scenarios Summary

The assignment is primarily a due diligence exercise that provides a “book value based on market value in fee simple” for the transaction (value in use); a worst case scenario if the Province does not acquire the property (low probability of occurrence given the need for a water supply for the community and other benefits to the surrounding area); and a market value based on continuing public purpose. The latter requires that the Province takes on the operational responsibility for public infrastructure from AAFC.

The primary challenge is the valuation of the lands under Scenario 1 and 2. Under Scenario 3 the land use restrictions of development within a flood zone need to be addressed. There may be some value to lands that are not subject to development restrictions if they are above the take line, of which there may be minor parcels under Scenario 3, however they would likely be of minor set-off value.

*Please note the costs provided by AAFC and PWGSC need to be checked for reasonableness.

5. Deliverables Continued

- Individual reports are required for each property.
- Appraisal Guidelines:

The appraisal report is to be completed in accordance with the “PWGSC Valuation Guidelines 1B1” which can be viewed at [1B1 Narrative Appraisal Report - Valuation Guidelines - Real Property - PWGSC](#). The report must also comply with the Appraisal Institute of Canada’s Canadian Uniform Standards of Professional Appraisal Practice.

- Use of both metric and imperial units are required for the report. The report is to be provided in English.
- Submission of a draft report for review of compliance with the 1B1 Guidelines is required prior to delivery of the final report. The draft report should be submitted electronically
- The Appraiser will produce the final report within 2 weeks after receiving comments on the draft final report.
- Six hard copies and one digital copy in PDF format of each final report are required.

6. Defined Terms

APPRAISER

The appraiser or appraisal firm engaged to complete the property valuation in accordance with the Statement of Work.

CLIENT

Public Works and Government Services Canada (Valuations Program).

EFFECTIVE VALUATION DATE

The effective date of appraisal is prospective at April 1, 2017.

HIGHEST AND BEST USE:

As defined by the Appraisal Institute of Canada being "the most profitable, likely use to which a property can be put. Alternatively, it is that use from among reasonably probable and legal alternative uses found to be physically possible, appropriately supported, financially feasible and which results in the highest land value. The opinion as to such a use is based on the most profitable, continuous use to which the property is adapted and for which there is likely to be a demand in the reasonably near future."

MARKET VALUE

As defined by the Appraisal Institute of Canada being "the most probable price which a property should bring in a competitive and open market under all conditions requisite to a fair sale, the buyer and seller each acting prudently and knowledgeably, and assuming the price is not affected by undue stimulus."

Implicit in the definition of Market Value is the consummation of a sale as of the effective date and the passing of title from seller to buyer under conditions whereby:

- (i) the buyer and seller are typically motivated.
- (ii) both parties are well informed or well advised and acting in what they consider their best interests;
- (iii) a "reasonable time" for exposure to the open market has passed as at the effective date of the appraisal;
- (iv) payment is made in cash in Canadian dollars or in terms of financial arrangements comparable thereto;
- (v) the price represents the normal consideration for the property sold unaffected by special or creative financing or sales concessions granted by anyone associated with the sale; and

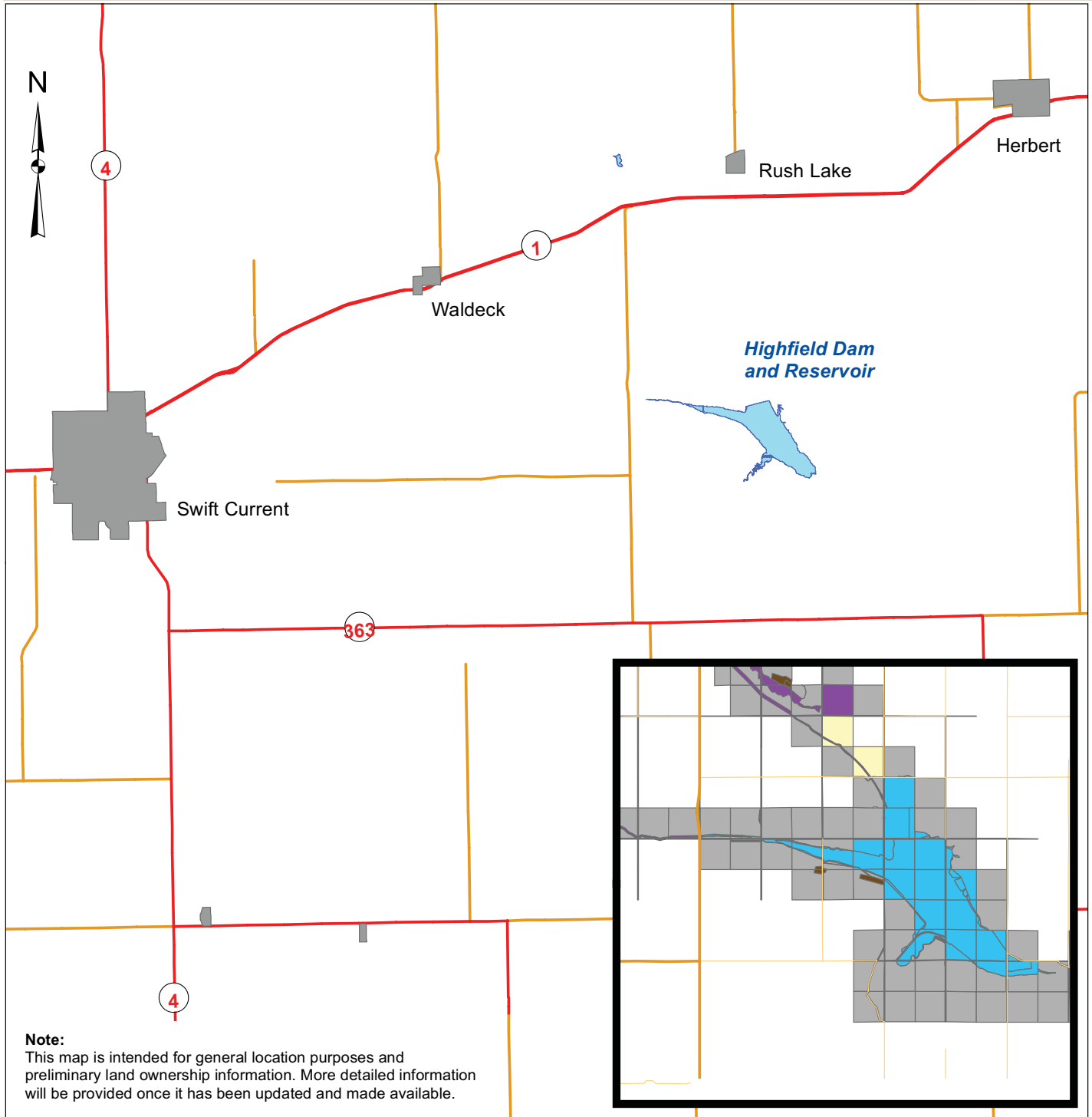

CYPRESS LAKE RESERVOIR - as at June 23, 2016

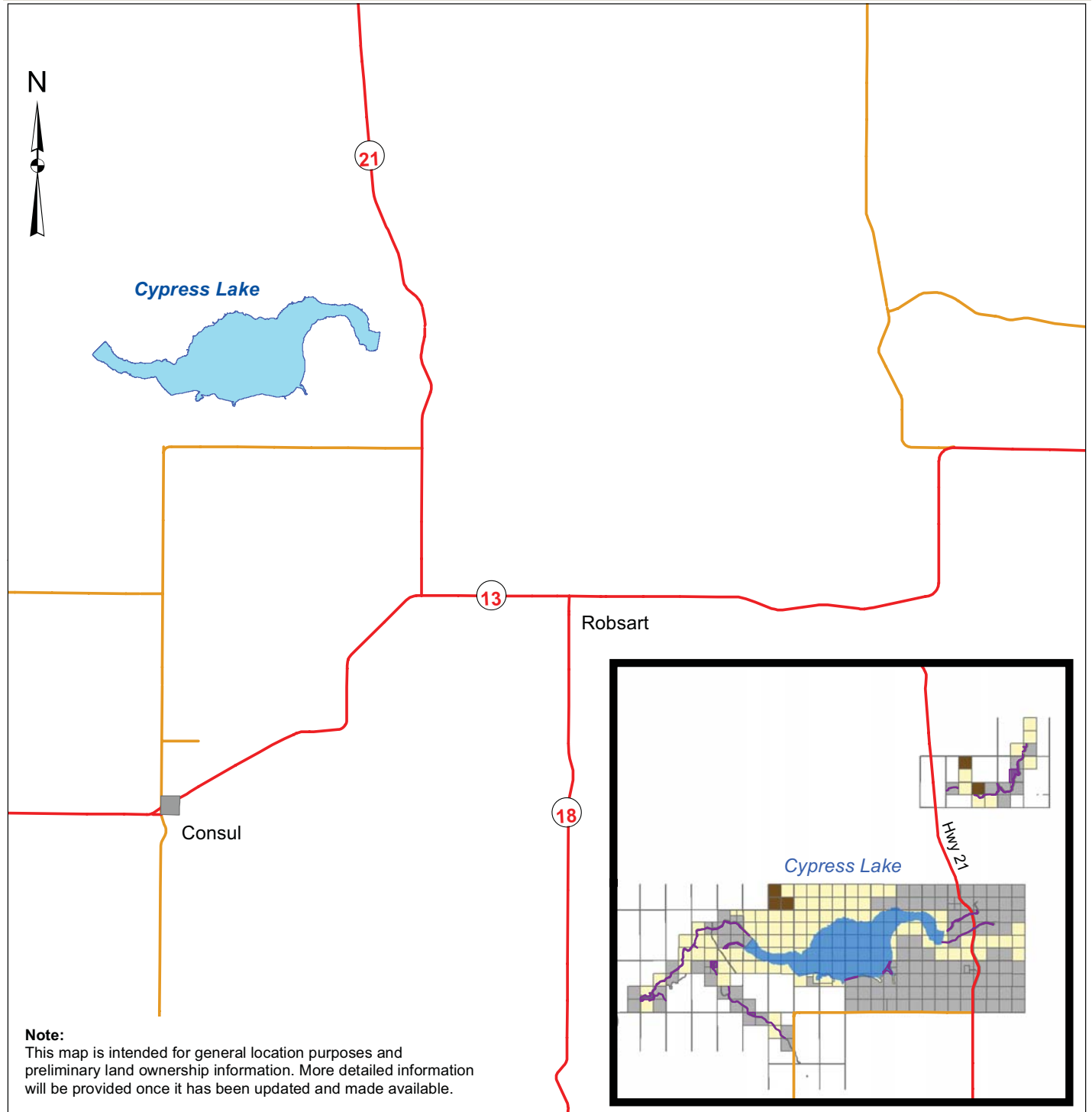

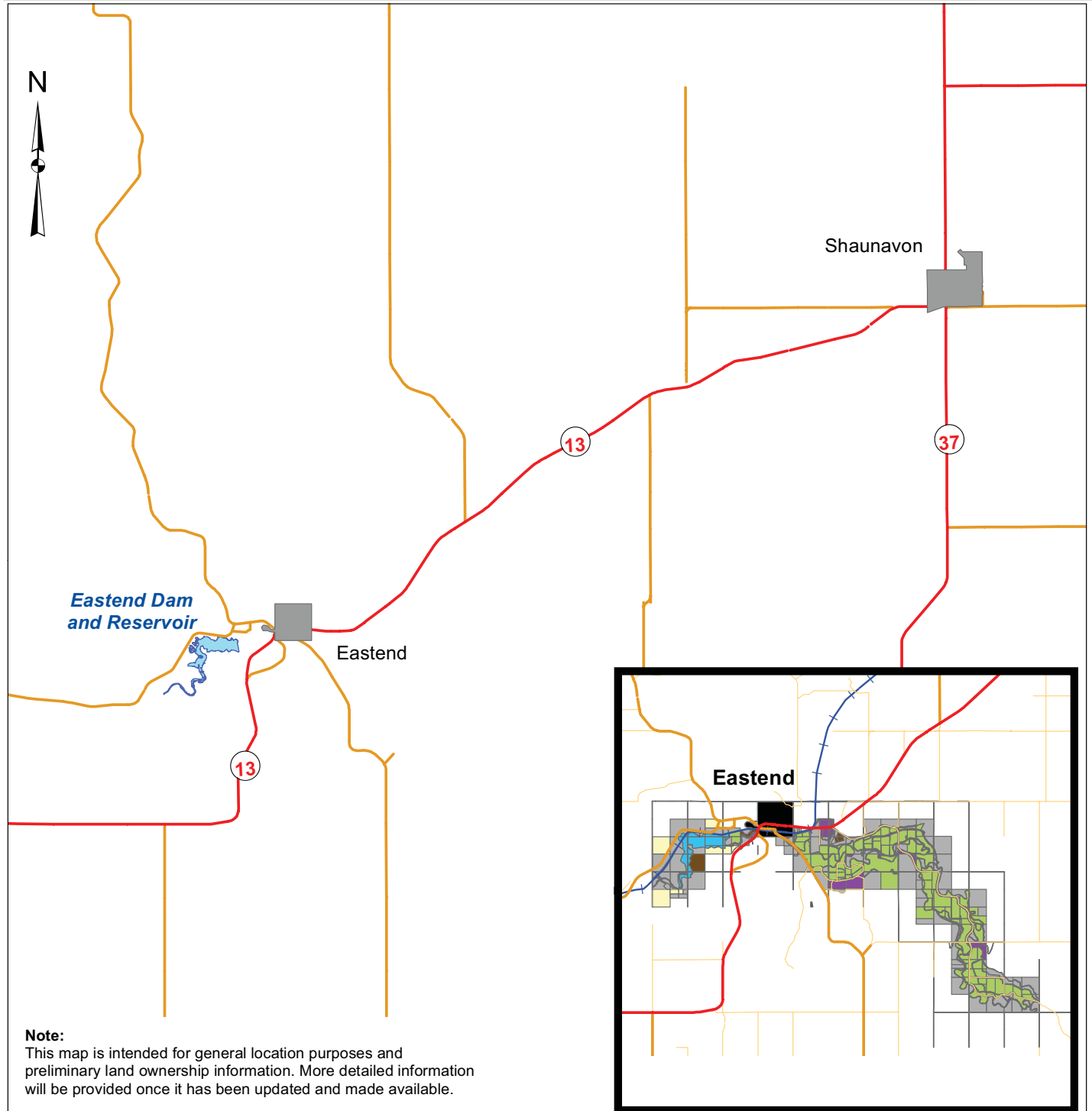

ANNEX "D"

INSURANCE REQUIREMENTS

Commercial General Liability Insurance

1. The Contractor must obtain Commercial General Liability Insurance, and maintain it in force throughout the duration of the Contract, in an amount usual for a contract of this nature, but for not less than \$2,000,000 per accident or occurrence and in the annual aggregate.
2. The Commercial General Liability policy must include the following:
 - a. Additional Insured: Canada is added as an additional insured, but only with respect to liability arising out of the Contractor's performance of the Contract. The interest of Canada should read as follows: Canada, as represented by Public Works and Government Services Canada.
 - b. Bodily Injury and Property Damage to third parties arising out of the operations of the Contractor.
 - c. Products and Completed Operations: Coverage for bodily injury or property damage arising out of goods or products manufactured, sold, handled, or distributed by the Contractor and/or arising out of operations that have been completed by the Contractor.
 - d. Personal Injury: While not limited to, the coverage must include Violation of Privacy, Libel and Slander, False Arrest, Detention or Imprisonment and Defamation of Character.
 - e. Cross Liability/Separation of Insureds: Without increasing the limit of liability, the policy must protect all insured parties to the full extent of coverage provided. Further, the policy must apply to each Insured in the same manner and to the same extent as if a separate policy had been issued to each.
 - f. Blanket Contractual Liability: The policy must, on a blanket basis or by specific reference to the Contract, extend to assumed liabilities with respect to contractual provisions.
 - g. Employees and, if applicable, Volunteers must be included as Additional Insured.
 - h. Employers' Liability (or confirmation that all employees are covered by Worker's compensation (WSIB) or similar program)
 - i. Broad Form Property Damage including Completed Operations: Expands the Property Damage coverage to include certain losses that would otherwise be excluded by the standard care, custody or control exclusion found in a standard policy.
 - j. Notice of Cancellation: The Insurer will endeavour to provide the Contracting Authority thirty (30) days written notice of policy cancellation.
 - k. If the policy is written on a claims-made basis, coverage must be in place for a period of at least 12 months after the completion or termination of the Contract.
 - l. Owners' or Contractors' Protective Liability: Covers the damages that the Contractor becomes legally obligated to pay arising out of the operations of a subcontractor.
 - m. Non-Owned Automobile Liability - Coverage for suits against the Contractor resulting from the use of hired or non-owned vehicles.
 - n. Litigation Rights: Pursuant to subsection 5(d) of the [Department of Justice Act](#), S.C. 1993, c. J-2, s.1, if a suit is instituted for or against Canada which the Insurer would, but for this clause, have the right to pursue or defend on behalf of Canada as an Additional Named Insured under the insurance policy, the Insurer must promptly contact the Attorney General of Canada to agree on the legal strategies by sending a letter, by registered mail or by courier, with an acknowledgement of receipt.

If Canada decides to co-defend any action brought against it, and Canada does not agree to a proposed settlement agreed to by the Contractor's insurer and the plaintiff(s) that would result in the settlement or dismissal of the action against Canada, then Canada will be responsible to the Contractor's insurer for any difference between the proposed settlement amount and the amount finally awarded or paid to the plaintiffs (inclusive of costs and interest) on behalf of Canada.
