

PART 1 - GENERAL INFORMATION

1. Statement of Work

The Work to be performed is detailed under Article 2 Statement of Work of the resulting contract clauses.

2. Revision of Departmental Name

As this bid solicitation is issued by Correctional Service Canada (CSC), any reference to Public Works and Government Services Canada (PWGSC) or its Minister contained in full text or by reference in any term, condition or clause of this document, or any resulting contract, must be interpreted as a reference to CSC or its Minister.

3. Set-aside Under the Federal Government Procurement Strategy for Aboriginal Business (PSAB)

This procurement is set aside under the federal government Procurement Strategy for Aboriginal Business.

Further to Article 1802 of the Agreement on Internal Trade (AIT), AIT does not apply to this procurement.

4. Debriefings


All enquiries must be submitted in writing to the Contracting Authority no later than Seven (7) business days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

4. Applicable Laws



The Project Authority is the representative of the department or agency for whom the Work is being carried out under the Contract and is responsible for all matters concerning the technical content of the Work under the Contract. Technical matters may be discussed with the Project

Authority, however the Project Authority has no authority to authorize changes to the scope of the Work. Changes to the scope of the Work can only be made through a contract amendment issued by the Contracting Authority.


9. Applicable Laws

11.Termination on Thirty Days Notice

- 11.1 Canada reserves the right to terminate the Contract at any time in whole or in part by giving thirty (30) calendar days written notice to the Contractor.
- 11.2 In the event of such termination, Canada will only pay for costs incurred for services rendered and accepted by Canada up to the date of the termination. Despite any other provision of the Contract, there will be no other costs that will be paid to the Contractor as a result of the termination.

12. Insurance

The Contractor is responsible for deciding if insurance coverage is necessary to fulfill its obligation under the Contract and to ensure compliance with any applicable law. Any insurance acquired or maintained by the Contractor is at its own expense and for its own benefit and protection. It does not release the Contractor from or reduce its liability under the Contract.

13. Ownership Control

Where the Contractor will have access to any and all personal and confidential information belonging to Canada, CSC staff or inmates for the performance of the work, the following will apply:

- (a) The Contractor warrants that it is not under ownership control of any non-resident entity (i.e. Individual, partnership, joint venture, corporation, limited liability company, parent company, affiliate or other).
- (b) The Contractor shall advise the Minister of any change in ownership control for the duration of the contract.
- (c) The Contractor acknowledges that the Minister has relied on this warranty in entering into this Contract and that, in the event of breach of such warranty, or in the event that the Contractor's ownership control becomes under a non-resident entity, the Minister shall have the right to treat this Contract as being in default and terminate the contract accordingly.
- (d) For the purposes of this clause, a non-resident entity is any individual, partnership, joint venture, corporation, limited liability company, parent company, affiliate or other residing outside of Canada.

14. Closure of Government Facilities

- 14.1 Contractor personnel are employees of the Contractor and are paid by the Contractor on the basis of services rendered. Where the Contractor or the Contractor's employees are providing services on government premises pursuant to this Contract and the said premises become non accessible due to evacuation or closure of government facilities, and consequently no Work is being performed as a result of the closure, Canada will not be liable for payment to the Contractor for the period of closure.
- 14.2 Contractors working at CSC sites should be aware that they may be faced with delay or refusal of entry to certain areas at certain times even if prior arrangements for access may

have been made. Contractors are advised to call in advance of travel to ensure that planned access is still available.

15. Tuberculosis Testing

- 15.1 It is a condition of this contract that the Contractor or any employees of the Contractor who require entry into a Correctional Service of Canada Institution to fulfill the conditions of the contract may, at the sole discretion of the Warden, be required to provide proof of and results of a recent tuberculin test for the purpose of determining their TB infection status.
- 15.2 Failure to provide proof of and results of a tuberculin test may result in the termination of the contract.
- 15.3 All costs related to such testing will be at the sole expense of the Contractor.

16. Compliance with CSC Policies

- 16.1 The Contractor agrees that its officers, servants, agents and subcontractors will comply with all regulations and policies in force at the site where the work covered by this contract is to be performed.
- 16.2 Unless otherwise provided in the contract, the Contractor shall obtain all permits and hold all certificates and licenses required for the performance of the Work.

17. Health and Labour Conditions

20. Contract Administration

The parties understand that the Procurement Ombudsman appointed pursuant to Subsection 22.1(1) of the *Department of Public Works and Government Services Act* will review a complaint filed by *the contractor* respecting administration of this contract if the requirements of Subsection 22.2(1) of the *Department of Public Works and Government Services Act* and Sections 15 and 16 of the *Procurement Ombudsman Regulations* have been met, and the interpretation and the application of the terms and conditions and the scope of work of this contract are not in dispute. ANNEX A - Statement of Work

With The Correctional Service Canada has a requirement to provide ongoing culturally-appropriate services to the Inuit offender population as outlined in the National and the Ontario Region Inuit Strategy. The work will involve the following:

1.1 Background:

Inuit offenders in the Ontario Region have been afforded the opportunity to participate in recording an annual Christmas Video. This program has allowed Inuit offenders to record personal greetings via video recordings and have the recordings sent to their family members in Nunavut. This is a valuable way for Inuit offenders to maintain connections with family members as these videos are often the only updates the family receives, given the high cost of travelling south from Nunavut.

12 Objectives:

The overall project objective is for the contractor to produce DVD's with personal greetings from lnuit offenders, which will ultimately be sent to the approved family members/identified contacts of the offenders. Each DVD is expected to last between approximately 3 and 5 minutes.

1.3 Tasks:

The contractor will visit the institutions listed below in order to video record personal greetings from Inuit offenders for delivery to family members. Inuit offenders will be given time to record a video greeting at their parent institution. The video recordings will be saved to a portable drive, which a CSC employee will retain, then transferred by the contractor onto DVDs on site at a CSC facility and/or RHO. The DVD's will be returned to CSC (Project Authority) for distribution to the offender's identified family member. An Inuktitut-speaking CSC staff member will be present during the recording, or alternatively to review the completed videos, to ensure the messages do not contain anything that would be considered a breach of CSC's security policy. Video recordings will be considered PROTECTED information and will not be removed from the institution by the contractor, remain under physical control of a CSC employee, will remain property of CSC at all times, and will not be distributed by the contractor at any time.

1.4 Deliverables:

The contractor must produce DVD's with personal greetings from Inuit offenders. The Project Authority will identify all Inuit offenders that will be provided the opportunity to record their greetings. Total duration of the project will be 5 months per year. Final product to be delivered by December 24th of each year.

1.5 Location of work:

- a. The Contractor must perform the work at the following institutions where Inuit offenders are located: Bath Institution, Beaver Creek Institution, Grand Valley Institution, Collins Bay Institution, Joyceville Institution, Millhaven Institution and Warkworth Institution. All video editing will be completed at RHQ Ontario.
- b. Travel
 - No separate travel is anticipated for performance of the work under this contract, these costs will be incorporated into the price per video.
- c. The majority of the project (70%) will occur in Gravenhurst with the remaining (30) occurring in Kitchener, Campbellford and Kingston.

1.6 Language of Work:

The contractor must perform all work in English.
